■ Buying a GEM Car With Club Discount Changed Her Life

Thursday October 5, a nice glossy flyer from the City Employees Club of Los Angeles encouraged City employees to "Go A Little Wild", and invited all of us to a party [the ClubFest] at the LA Zoo. The reverse side of the flyer pictured the vehicle I have dreamed of, and envisioned, all of my life, since I was 5 years old. Only a week before, a Commuter News letter similarly invited City employees to celebrate California Rideshare Week. An article mentioned our colleagues test-driving Chrysler GEM electric vehicles on their way to car pool, or park and ride facilities.

I looked at the picture and thought, That's it! That vehicle looks exactly like what I need to confront and overcome my aversion to driving. It has perfect visibility in every direction; four wheels instead of two or three; wide wheels so it won't tip over; a seat; storage room; and you do not have to wear a dorky helmet while you operate it. It has none of the confining features of traditional vehicles, in which I feel blinded and trapped trying to operate, and no smelly, messy gasoline. Electricity works like neural firing, the same power as the human brain.

I knew I had to have one, and I found the

testimonials from other ridesharing kindred spirits encouraging. The ride-sharing article indicated that people win prizes for this, which struck me as news, because my biggest shame in life and sense of failure ties to my paralyzing fear of driving a traditional automobile. I cannot even balance a two-wheel bicycle, or razor scooter. I feared I had a lifetime position in the

Transportation Challenged Hall of Fame.

Mind you, I from Hoboken, NJ, by selling my art work, and came to Los Angeles by bus in 1977. Since that time I have supported myself as a starying artist, raised a daughter by myself, earned a master's degree, launched a decent career, bought my own home and secured more than \$10 million

in grants and proposals. I took the 100-foot leap from the ropes course, skied, skated and walked through Central Park at night. Challenges never scare me off, and except for driving, fear has no place in my life.

Relying on the generosity of my daughter to drive me, I hurried on over to the LA Zoo, to see the GEM for myself. The volume of the

crowd startled me and did not lend itself to overcoming lifelong fears. Undaunted, I turned around and went home, but promised myself to call the City Employees Club first thing Monday, and learn more about the Chrysler GEM.

With the enthusiastic guidance of Chris Hills, and a Goddess of Mobility named Alicia, I discovered the best news in my transportation-challenged life. They told me that the GEM retails for \$7,500, which would not be bad. But even better, members of the City Employees Club can get a 2002 two-seater for \$3,100, plus a \$500 shipping fee, to get them here from Duluth, Minn. Chrysler also makes four-seaters, and two-seaters with long or short utility beds, but the two-seater, in choice of red, yellow, blue, or white, costs the least, and goes the farthest on one charge, due to its lighter structure.

GEMS go no faster than 25 MPH, and a maximum of 35 miles per charge, but a normal extension cord and household outlet permit recharging for a cost of about a penny a mile. Although street legal, they go too slowly to take on the freeway. I considered the limitations of the GEM compared with the limitations of my

fear, and the GEM won out. I have made zero progress since getting my first license 20 years ago. I call the GEM my training wheels.

Chris and Alicia sent me to Center Chrysler Jeep in Sherman Oaks, and I needed every word of information they gave me, including proof of my membership in the City Employees Club, another unbelievable bargain at a mere \$4 per month. The sales rep incorrectly inferred that LA City Club had the same deal as COSTCO employees receive, but that deal costs more for a 2001 model, with a much shorter warrantee. It did not sound right, so I stuck with what I had heard, and before I returned from my test drive Alicia had faxed the sales manager a copy of our superior deal, and I walked out paying no more than Chris and Alicia had prepared me to.

The simplicity of it delighted me, too. While they ran the credit check, I had time to read the entire owners manual, and write down all of my questions, which they gleefully answered to my full satisfaction. For \$3,700 I drove home in a white 2002 two-seater, with a three-year extended warrantee, mud flaps and scuff guards. GEMS do not offer many extras. I put \$1,000 down and I only have to pay \$100 a month.

Because I did not want to begin my maiden voyage with a left turn onto Van Nuys Boulevard, the sales rep rode around the block with me, and I took Magnolia to Sepulveda. I survived my first left turn and another on to Ventura Boulevard. It took all of my courage to do this, but by the time I passed Havenhurst, I found the journey downright enjoyable.

I already knew I could handle speed in excess of 25 MPH if the vehicle could do it, that my fear had more to do with visibility than speed. I knew the skill and confidence I could build from this experience would generalize to

really driving a real car in the very near future. It dawned on me that I have not driven solo in 20 years, and until now I had never enjoyed a single drive. For the first time in my life, I put the pedal to the metal, and drove without posing a danger to myself and others.

The next day I had to gather all of my courage all over again. Maybe I always will, but I did it again. For the first time in her life, I took my daughter for a drive, and we laughed! The GEM has a road or turf setting, so you can take it on the golf course and not tear up the grass. We experimented with this and cruised under the wires in a grassy area near our house. This seemed terribly funny for some reason. She wanted to try it too, and said it was cool. She thinks all of her friends will want one. You sure can't beat the cost of fuel or payments, and I can't put a price on the freedom that awaits me as I drive away from the most debilitating fear I have ever had to overcome.



LA Workforce Can Set Civic Standard

Election season is upon us and I want to encourage all City employees to get out and vote this Tuesday, November 5. This is your opportunity to exercise your right to vote and help shape your community on a local, statewide and national level. Many important races and initiatives are on the November ballot – including election of the governor and other statewide offices, propositions, bond measures, congressional races and citywide measures.

Recent elections have sent a clear message that every vote counts. We all remember how the outcome of the 2000 presidential election came down to a few hundred votes in a few local communities. My own City Council race in March was decided by just 212 votes

Unfortunately, the number of citizens turning out to vote continues to decline. Americans are becoming less engaged and less active with their government. Here in Los Angeles we can buck this unhealthy national trend – not only by turning out to vote – but by participating in our communities.

I encourage those of you who live in the City of Los Angeles to take an active role in your neighborhood. Our growing system of neighborhood councils provides city employees with additional tools to engage local communities

During my first six months in office, I have seen first-hand the extraordinary synergy that takes place when neighborhood residents and our City workforce join together to tackle community problems. In July of this year, an army of community volunteers and Bureau of Street Services staff teamed up to identify and repair 747 potholes and other road damage in a single weekend. On a single Saturday in September, Department of Transportation staff worked with neighborhood volunteers to tow, ticket or mark nearly 300 abandoned vehicles blighting the North Hollywood community.

Community-based service delivery is an effective tool to address quality-of-life issues in our neighborhoods. Staff can tap residents' knowledge to focus City efforts while local residents are able to see the high standards and extraordinary dedication of our city workforce in action. With continued emphasis on community participation – in the voting booth and on and off the job – the LA City workforce can set the standard other cities should follow.

Voting Guide

Other City and County Measures

- Measure K: Los Angeles Unified School District voters also will decide on Measure K, which provides for the issuance of \$3.35 billion in general obligation bonds for specified district improvements. The district indicates that this measure will allow for building new neighborhood schools, repairing aging and deteriorating classrooms, improving early childhood programs, expanding public charter schools, and more.
- Measures A & B: Throughout Los Angeles County, voters will decide on both Measure A the Earthquake and Fire Safety Bond, and Measure B the Preservation of Trauma Centers and Emergency Medical Services; Bioterrorism Response. Each measure requires a two-thirds majority to pass.

According to the League of Women Voters of California's "Smart Voter" Website, Measures A and B ask the following questions:

Measure A: "To ensure that the Natural History Museum and other County Museums meet strict earthquake and fire safety standards, generate at least \$250 million in private donations for these facilities, provide 50 percent more free admissions for student groups and children, and assure fire and earthquake-safe science and arts education facilities, shall the County issue up to \$250 million in bonds on the condition that the private donations be received first, with review by an Independent Oversight Committee?"

Measure B: "To avoid the life-threatening shutdown of Los Angeles County's trauma network, maintain and expand the trauma network countywide, ensure more timely response to critical and urgent medical emergencies and respond effectively to biological or chemical terrorism, shall all property owners pay an annual tax of 3 cents per square-foot of improvements (buildings) on developed property?"

State Propositions and Decisions

Of course, this year Californians also will vote for governor, plus a number of other elected offices. Seven statewide propositions also are on the ballot:

- **Proposition 46:** Housing and Emergency Shelter Trust Fund Act of 2002.
- **Proposition 47:** Kindergarten-University Public Education Facilities Bond Act of 2002.
- **Proposition 48:** Court Consolidation. Legislative Constitutional Amendment.
- **Proposition 49:** Before and After School Programs. State Grants. Initiative Statute.
- **Proposition 50:** Water Quality, Supply and Safe Drinking Water Projects. Coastal Wetlands Purchase and Protection. Bonds. Initiative Statute.
- **Proposition 51:** Transportation. Distribution of Existing Motor Vehicle Sales and Use Tax. Initiative Statute.
- **Proposition 52:** Election Day Voter Registration. Voter Fraud Penalties. Initiative Statute.

Bratton Named New LAPD Chief

■ Mayor Hahn picks former New Yorker to head LA's police force.

William Bratton, former head of New York City's police force, was named late last month as the next chief of the Los Angeles Police Department.

The announcement came at the culmination of a months-long search by Mayor James Hahn to replace former LAPD chief Bernard

Bratton, who led the NYPD from 1994 to 1996, is credited with helping lower New York City's crime rate during that time. Serious crimes – murder, rape and robbery – dropped by nearly a third under his watch, although some cite economic and demographic changes as contributors.

Bratton, 54, wrote a book, *Turnaround*, about his tenure atop the NYPD. He also spent a year on the team overseeing the LAPD's compliance with a federal consent decree. He left that board when he decided to apply for the LAPD chief's job.

In introducing the new chief to the city at a press conference at the North Hollywood LAPD station, Mayor Hahn said of his

"Our proud department has faced many challenges: the Rampart scandal, the implementation of a federal consent decree, low morale, high attrition and poor recruitment. Community policing was largely dismantled, while crime has continued to rise.

"But we are beginning to see positive changes at Parker Center, and the luster is being restored to the LAPD badge... We must continue our progress. 



The Los Angeles Department of Transportation has the national reputation as being one of the premier transportation organizations in the country. It is well deserved. Since its creation in 1979, the Department and its members have distinguished themselves in many areas. Its engi-

neers have been leaders in the development and deployment of advanced traffic management systems to combat congestion. They have been at the cutting edge in using technology to move buses quicker in the enormously successful rapid bus lines.

On the streets, one of the country's largest team of traffic officers facilitates the flow of traffic and enforces a wide range of parking regulations. A special operations unit manages traffic associated with hundreds of events

including the Academy Awards and the Los Angeles Marathon. The transit staff manages the popular community DASH and commuter express lines and specialized senior transit services that are used by 25 million passengers annually. Investigators regulate the massive taxicab industry and the medical transportation companies that serve Los Angeles. Members of the Department operate more than 100 parking facilities and manage the Metrolink transit stations in Los Angeles.

In concert with the community, the DOT staff works hard to develop and implement solutions to mitigate the negative impacts of traffic and to ensure the safe access to nearly 1000 schools. In partnership with other agencies, both inside and outside the City, DOT staff work to plan, fund and construct freeway improvements, rail lines, parking facilities, transit stations and street, bicycle and pedestrian projects. In accordance with the requirements of the Department, private developers fund needed transportation improvements.

The success of the Department is largely the result of the dedication and talents of its 2000 members. They are transportation planners, accountants, auditors, technicians, hearing officers, investigators and engineers. They

serve in a wide variety of maintenance and construction professions. They are traffic officers, analysts, clerks, secretaries, communications operators and adult crossing guards. They are some of the very best in public service.


There are extraordinary examples of that




A Day in the Life of the Department of Transportation















Department of Transportation: Moving L.A. Forward

■ Few cities in the world move at the speed of **Los Angeles: What makes it work?**

.A.'s Department of Transportation is Libut one of the entities that keeps the city on the go. But it's one of the largest and most important.

More than 2,200 employees make up the department. Although 400 to 500 are stationed at the department's headquarters downtown, the remainder is spread out among 23 different locations.

And while you might encounter the department's representatives at times of duress - think parking enforcement - the Department of Transportation goes much deeper than that. (But while we're on the subject of parking enforcement - those offices play a vital role in keeping Los Angeles moving. So give 'em a break.)

Any virtual tour of the department must stop in the Automated Traffic Systems and Control (ATSAC) center, deep in the basement of City Hall East. There, dedicated men and women control 2,600 of the City's 4,300 traffic signals via a state-of-the-art facility.

The Department also developed and patented software that figures out optimal traffic signal settings. Other metropolitan areas are now using this cutting-edge software.

Signal-maintenance and sign making are two more significant functions. In fact, the Department is believed to be the only one in the country to own its own thermoplastic formation equipment. (The machine costs \$250,000, according to General Manager James Tanda, making its functionality usually provided by contractors.) LADOT is the only city large enough to enjoy having its own thermoplastic formation equipment in house.

And then there's the traffic and parking enforcement officers (numbering about 600),

who write more than 3.2 million citations per year. "It's important to focus attention on these officers," Tanda says. "They try to gain an adherence to regulations that promote safety (red curbs), promote economic development (parking time limits), promote neighborhood liveability (permits) and combat congestion (towing vehicles in traffic lanes). They also assure that the disabled have a place to park, and they enforce regulations regarding vehicles on private property.

"They are seldom recognized for the important job they do."

The Department also manages liaisons with contractors, including for the localized DASH bus service.

And then there's the department's watchdog function over franchises, including taxicabs, ambulances, pipelines and other services. "They're out there doing great work," Tanda said of those making sure the cab and ambulance drivers are licensed and legitimate.

Project managers and planners work with other agencies to help build and maintain freeway interchanges, light rail inspections and the

Have a complaint? You'd probably want to talk to district operations, which deals with constituent concerns (that means people who have a beef or need a traffic condition dealt with). District operations handles more than 17,000 requests per year, requests to address speed limits, safe access to schools, localized congestion, etc.

Finally, there are the support services info tech officers, personnel, budgeting, accounting, clerical, purchasing and the like.

It takes most every one of them to keep L.A. moving.





Thinking About Elective Surgery?

■ Here Are Some Things to Know

ne out of ten Americans will become a hospital patient this year. More than ever, patients need to know what to expect and how to cope with a hospital stay. The health care industry is in a period of transition, and soaring costs have forced many mergers. The new consolidations are forced to lay off nurses and other aides. Meanwhile, HMOs are calling for fewer medical tests and shorter hospital stays.

The first step is to get over the awe we have for the medical profession, and become a smart consumer. Make believe you're buying a new car, and approach your hospitalization as a customer who knows what you want and what you expect to get.

Following is a checklist of things to do before you enter a hospital:

✓ Is Your Hospitalization Necessary?

• Always get a second opinion. Many procedures that once required hospitalization can now be done on an outpatient basis – for instance, cataract surgery.

✓ Meet Your Surgeon Ahead of Time

- Insist on a personal meeting with the surgeon far ahead of the surgery. When you meet with the surgeon, take notes. Better yet, take a tape recorder.
- Get a commitment that your surgeon will perform the entire surgery, and not simply get it started and turn it over to an assistant surgeon to complete the operation.
- Make sure the surgeon who will perform the surgery is board-certified.
- Remember, it's your right to have confidence in your surgeon.

✓ Choosing the Hospital

• Your doctor and/or surgeon will want to send you to the hospital where they are

on staff. Your HMO may want to send you to a hospital that charges the least. Some hospitals are better than others in terms of their medical record. Check out the hospital's reputation any way you can.

• Don't be shy about visiting the hospital in advance of the surgery to see the patient rooms and meet the staff. Always know who will be in charge of your hospital stay at every stage.

✓ Meet the Anesthesiologist and Discuss Your Medical History With Him/Her

• Ask what type of anesthesia will be used and its after-affects. Inform the anesthesiologist of any allergic reactions you may have.

Don't Sign Any Forms Until You Completely Understand What the Forms Are For and How They Will Affect Your Treatment Options

• When you arrive at the hospital, you will be presented with a variety of forms to sign on the spot. Take the time to read them carefully. Also, put any personal treatment decisions in writing. Give the hospital a signed copy of your "living will," which tells the hospital what steps to take regarding life-support measures.

✔ Plan for Your Hospital Departure and Recovery Before You Go to the Hospital

- Make arrangements for transportation back home.
- Arrange in advance for special in-home medical equipment (walkers, hospital beds, etc.) or home health care professionals (nurses, therapists, et al.)
- Ask what danger signals to look for in your recuperating process.

Finally, Don't Sign Your Hospital Bill Without Examining It

• Hospitals make many mistakes on bills. You are certain to find charges on your bill for services or supplies you never received.

- Never give your credit card, checking account or social security number to an unknown caller.



SEE THE LIGHTS

The Department of Public Works Bureau of Street Lighting (BSL), in conjunction with Councilmember Tom LaBonge (Council District 4), are scheduled to activate a new street lighting system in Spaulding Square October 26, in conjunction with the Spaulding Square Neighborhood Association's Harvest Festival.

- "The Bureau worked diligently with the community to see this come to fruition, including installing the lights with our own crews," said Board of Public Works Commissioner Janice Wood. "This is a good example of what can be achieved when communities partner with the City of Los Angeles."
- The project includes installation of 34 ornamental historic streetlights to complement and enhance the existing modern streetlights. The benefiting property owners agreed to pay the full cost of installation and increased maintenance to enhance the aesthetics of their neighborhood. The lighting system is bounded by Sunset Avenue to the north, Fountain Avenue to the south, Fairfax Avenue to the west, and Stanley Avenue to the east. Construction costs totaled \$140,000.

CLAIMS UPDATE

Apply for Disability Insurance Now, Before It's Too Late

▼i! It was good to see so many of you at the ClubFest

This month, I want to present a good case study about how disability claims work - and don't work.

Peter is a husband and father of two beautiful children. He doesn't want to even think about signing up

for disability insurance because he thinks he'll never need it; he sees a physician occasionally and he ultimately feels he is in good shape. Suddenly he starts encountering symptoms, and his health deteriorates. He realizes that maybe he will need disability insurance after all. So, he applies for disability insurance, and when he completes the medical questionnaire on the insurance applica-

tion he tries to ignore his symptoms. Luckily, Peter's application is approved. Now he is insured. During several months of taking his physician prescribed medication, the doctor puts him out on disability. Now that Peter has disability insurance, he files a disability claim without knowing of the pre-existing conditions insurance clause in his policy.

All disability insurance plans contain a pre-existing condition clause. It means that if you are injured or if you become sick and you received medical treatment during the six months before you became insured, you are not eligible for disability benefits.

In our disability plan, if total disability is due to a pre-existing condition, you may be still eligible for benefits if:

- Your first 12 months of insured, you do not require any form of treatment or medication for the pre-existing condition, or
- Your total disability begins after 24 months of the date you became insured by this plan.

BOTTOM LINE:

Apply for Disability Insurance while you are healthy.





Orange Cranberry Turkey Sandwiches

INGREDIENTS

- (1) medium-size sweet onion (such as Maui), thinly sliced
- (3) tablespoons apple cider vinegar
- (2) tablespoons chopped fresh dill
- (2) teaspoons sugar
- (3/4) cup canned whole-berry cranberry sauce
- $(1^{1}/_{2})$ teaspoons grated orange peel
- Salt and freshly ground pepper (to taste)
- (8) slices whole grain bread, toasted
- (8) ounces thinly sliced turkey breast
- (1) bunch watercress, thick stems trimmed

DIRECTIONS

Mix onion, apple cider vinegar, dill and sugar in medium bowl. Season to taste with salt and pepper. Mix cranberry sauce and orange peel in small bowl. (Onion mixture and cranberry mixture can be prepared 1 day ahead. Cover separately and refrigerate.) Place all bread slices on work surface. Spread cranberry mixture over slices, dividing equally. Top 4 bread slices with onion mixture, then turkey and watercress, dividing equally. Top with remaining 4 bread slices, cranberry side down, and serve.

Roasted Garlic-Parmesan Bread

INGREDIENTS

- (1) head garlic, cloves separated but not peeled
- (1) tablespoon extra virgin olive oil
- Salt and freshly ground pepper
- Parmesan cheese (preferably not pre-grated; get the
- (2) ¹/₃-inch-thick 5 x 3-inch French bread slices
- Extra Virgin Olive
- Dried rosemary, crumbled
- Sea salt and freshly ground pepper

DIRECTIONS

- Preheat oven to 350°F. Toss garlic with 1 tablespoon oil, salt and pepper in small baking dish. Roast until soft, about 30 minutes. Release garlic from peels into small bowl. Mash with fork.
- Preheat broiler. Toast 1 side of bread under broiler. Brush second side with oil. Grate Parmesan cheese and sprinkle with rosemary, salt and pepper. Broil until golden brown. Spread with garlic. Serve hot.

The tasty Orange Cranberry Turkey Sandwiches can be a tasty quick fix for those taste buds; the Roasted Garlic-Parmesan Bread is a treat during the holidays; and I'll give you a way to turn those turkey dinner leftovers into a gourmet delight with Very Simple Pumpkin Soup.

Very Simple Pumpkin Soup

Try serving a Chardonnay with this. It's really good. If there are kids at the table, offer them apple cider.

INGREDIENTS

- (2) 15-ounce cans pure pumpkin
- (4) cups water
- (1) cup half and half
- (1) garlic clove, pressed
- (1/4) cup pure maple syrup
- (4) tablespoons unsalted butter
- (1/2) teaspoon Chinese five spice powder (a blend of ground anise, cinnamon, star anise, cloves, and ginger available in the spice section of most supermarkets)
- (4) ounces fresh mushrooms (any edible kind is okay), stemmed, sliced

DIRECTIONS

Bring first 4 ingredients to simmer in large saucepan over medium-high heat, whisking often. Whisk in syrup, 2 tablespoons butter, and five-spice powder. Simmer soup 10 minutes, whisking often. Season with salt and pepper. (Soup can be made 1 day ahead. Chill until cold, then cover and keep chilled. Bring to simmer before serving.) Melt remaining 2 tablespoons butter in heavy medium skillet over medium-high heat. Add mushrooms; sauté until tender, about 10 minutes. Divide soup among 6 bowls. Sprinkle soup with mushrooms, dividing equally. If you have pumpkin oil, give your soup a drop or two to intensify the pumpkin flavor; serve.





Understanding Your Benefits

■ These Tips Can Make Your Retirement Transition Easier

▼i! I'm sure many of you know me – I was the one handing out the prizes at the Hi! I'm sure many or you know me - 1 was one of the ClubFest last month (that was fun, wasn't it?). But my regular job is working for the City Employees Association of Los Angeles (the Club) as a benefits counselor.

I love answering your questions on benefits. Heck, I do it every day. So we figured we should have some space in Alive! to answer your very general questions. Insurance benefits can get confusing and complex with the multiplicity of procedure and regulation placed on them. So, submit your questions on benefits so that we can all understand how to make sure we are protected.

If you need a more personal answer, please don't hesitate to write or call me. So, let's get started.

Question:

Do I need to do anything with my insurance benefits with the City Employees Club when I retiree from

Answer: Yes. There are a few details that retiring city employees must follow to avoid delays and even loss of coverages. When you know your retirement date from city service, call the City Employees Club to receive your retirement packet that includes the Retirement Options Forms. The packet asks for information that allows you and your spouse to continue benefits with the City Employees Club. If you are going to retire, or have retired, call me.

Question:

Can I just call the City Employees Club to adjust my benefits over the phone?

Answer: No. It is important to note that you must inform the City Employees Club in writing that you will continue with your benefits. Without the Retiree Options Forms and proper insurance benefit applications, you and your spouse's benefits will end after 31 days from your retirement date. After 31 days, you and your spouse must re-apply for insurance benefits and may take (at best) 6 weeks for a decision to occur. It may take longer if the insurance carrier requests health and medical information.

Question:

Can I still have benefits with the City Employees Club after 31 days of my retirement?

Answer: You and your spouse may apply for benefits and you may be subject to a review of your health and medical information.

What if I retired from city service but I have never had benefits from the City Employees Club of Los Angeles?

Answer: Once you submit an application for membership to the City Employees Club of Los Angeles, you are then eligible to apply for plans such as life, accidental death and dismemberment, auto, homeowners, and longterm care insurance.

Question:

Can I request changes and information on my insurance benefits with the City of Los Angeles Benefits Office or Retirement System at the Club phone number?

Answer: No. You must call the City Benefits Office or the City Retirement System. The number for the City Benefits Office is (800) 778-2133; the number for the Los Angeles City Employees Retirement System is (800) 779-8328.
