# A Dream Come True For LAPD Officer From Scotland

# Meet Angela Stewart, who works hard to keep young teens on the straight and narrow.

"There are a lot

of big-hearted

police officers out

there who go way

above and beyond

what they're

required to do."

Like you, Angela Stewart serves the City with pride and dedication. But no doubt unlike you, this native of Scotland took a long and unusual path from the small town of Dalry to the metropolis of Los Angeles to become a City employee and fulfill her childhood dream of working as a police officer.

Stewart, a youth services officer in the Los Angeles Police Department's Foothill Division, joined the LAPD nine years ago after emigrating to the United States to join her father, and waiting the required period to become a U.S. citizen.

As a youth services officer, Stewart supports her adopted city by working with the Law Enforcement Explorer Program, for youths aged 14 to 21. Established in 1962, the program allows volunteer youth participants to

assist police officers with non-hazardous functions, including crowd and traffic control, and provides special training for future careers in law enforcement. In addition, the program frees up thousands of hours for police officers to handle other assignments.

Stewart recently oversaw the work of several Explorers who directed attendees at the swearing in ceremony of new LAPD

Chief William Bratton. "I really enjoy working with the kids," she said. "I see a lot of kids come into the program shy and not very outgoing, and start to see them mature into these very neat young men and women with more confidence. It's really nice to watch."

Stewart added that the Explorers, who must maintain a "C" average in school, often come from inner city and gang-infested neighborhoods, but don't want to take a negative life path. "They really put their necks out for the City," she noted. "They choose to try to better themselves and do something with their lives. It gives them a lot of confidence and exposes them to a whole other career path they might not have considered."

Stewart's own career path with the LAPD has seen her work in a number of capacities. When she came to this country at age 20, she went to Parker Center to find out about becoming an officer, and learned she first needed to obtain her U.S. citizenship. After doing so five years later, she couldn't get a position in the LAPD because of a hiring freeze, so while she worked at another job, she "bided her time" and volunteered for the LAPD IBARS (Immediate Booking and Release System) program for two years, helping

officers process paperwork for arrests.

Finally, in 1993, the dream she'd had since about age 10 became a reality, and she joined the LAPD in the Hollywood Division. Since then she also has worked at the Juvenile and West L.A. divisions in patrol and community relations, among other areas.

"When I worked patrol, I loved it," Stewart said. "It just so happened I was given the opportunity to try a different job. That's the beauty of working for the LAPD. There are so many jobs you can apply for and try." This variety, she added, "keeps it interesting."

Stewart now balances her commitment to work—which includes meetings every Wednesday night with the Explorers in her division—with her commitment to her husband, Greg Darvishian (a chef), and their first child, 18-month-old Meg Olivia. Having a

> child, she said, gave her a new perspective on her involvement with the Explorers. "You kind of start thinking how you would like your child to be treated if he or she were in an organization [like this]," she explained.

The Explorer Program encourages youth in the community to look to police officers as role models, an important point to Stewart because she thinks the pub-

lic doesn't always hear enough about the good deeds of many officers.

"There are a lot of big-hearted police officers out there who go way above and beyond what they're required to do," she said.

Stewart makes time to attend parent meetings at the elementary school near her home to give parents the latest information about child safety programs and other issues. "We need to be approachable," she said. It's very important to have strong ties to the community."

## **Bringing Faiths Together**


# John Popoch, Recreation Coordinator, Department of Recreation and Parks

Christmas in the Philippines revolves mainly around the spirit of giving and merrymaking, and even without snow or pine trees, there is no doubt it is Christmas in the Philippines. The Philippines is the only Asian country where Christians predominate, and Filipinos are proud to proclaim this holiday to be the longest and merriest.

Many Filipino yuletide traditions have their roots from the Spanish colonial era. The

Misa de Gallo, for example, is a pre-dawn Mass celebrated during the nine days preceding Christmas. These dawn Masses begin December 16 to 24 and could usually start as early as 4 a.m. The liturgical point was not to get people to sacrifice a few hours of precious sleep but to heighten their expectation for Christmas; and it is at this Mass where the story behind the birth of Christ is read from the

It is also customary for Filipino families to sit down to a feast on Christmas Eve after the Misa de Gallo Mass. Called the Noche Buena, the feast is in part a thanksgiving for the blessings of the year past, as well as a prayerful feast for a

Bible.

prosperous year to come. Traditionally served on every table are the jamon (ham), queso de bola (cheese), lechon (roasted pig), pancit, barbeque, fresh lumpia (spring roll), a variety of desserts from native rice cakes to buko (coconut) fruit salad, leche flan, and much more. Christmas Eve is a night without sleep and a continuous celebration moving right into Christmas Day. On Christmas morning, it is a Filipino tradition for children to visit their godparents, where they are presented with a gift, usually money.

Another tradition is the hanging of lanterns in front of the house. Not content with having a Christmas tree (green, white or aluminum—it does not really matter), the Filipino home will not be found without a parol (lantern) during the Christmas season. The parol emits a warm, unparalleled representation among holiday adornments and is unique to the Philippines.

> The celebration continues through the welcoming of the New Year's and at the strike of midnight, New Year's day is greeted by bursts of firecrackers, folks blowing horns, playing music ever so loud, setting off fireworks, beliefs such as open-

ing all doors and windows during the first day of the New Year to bring in good luck, noisebanging of pots and pans believed that the noise drives off evil spirits.

Christmas celebration ends after the Feast of the Three Kings January 6. Indeed, while songs may mention snow and sleds, in the Philippines, Christmas has gone beyond a changing of seasons. It has become a state of mind shared by an entire people.

The Bureau of Street Lighting (one of six **L** Bureaus in the Department of Public Works) is responsible for the planning, design, construction, operation and maintenance of the street lighting system in Los


Angeles. Los Angeles has one of the largest municipal systems in the country and the world. We have approximately 230,000 streetlights with close to 400 different styles.

systems Our are designed to National Standards for Roadway Lighting (which we help to develop) adopted by the Board of Public Works, and we are constantly exploring new technology to ensure that street lighting in Los

Angeles maximizes light output for every single watt of energy expended.

We hire civil and electrical engineers and teach them illumination engineering. We actively recruit on college campuses for young men and women who are interested in a rewarding career in the field of lighting, which is both an art and a science.

The importance of good lighting and its relationship to public safety cannot be over-

The Bureau also has its own construction forces, and we regularly coordinate with other City departments and other public agencies to deliver quality lighting projects "better, faster, cheaper and safer." Our services are available to all City departments and include not only street lighting but also the lighting

of bike paths, parking lots, parks, schools, sports fields and public facilities.

As one-third of Los Angeles does not have street lights, it is our goal to provide good quality lighting to every neighborhood that desires such. We are actively pursuing funding to accomplish this. With the continued support of our City family and our outstanding employees, street lighting in Los Angeles will continue to set the standard for excellence.



# **Bureau of Street Lighting: PROFILE**

The Bureau of Street Lighting is one of six Bureaus in the City of Los Angeles' Department of Public Works. Street Lighting is responsible for the design, construction, operation, maintenance and repair of the City's street lighting system. There are more than 230,000 existing streetlights consisting of more than 400 designs. Street lights provide illumination for streets, sidewalks, bus stops, transit stations and bike paths. The Bureau is organized by distinct functions: an engineering staff that will design and administer the construction contracts; a field operations crew that repairs and constructs street lighting systems; an assessment engineering group that administers the assessment districts; and a community services group that provide outreach and coordination with community groups, council offices and other city staff.

With its 230 employees in three main locations responsible for more than 230,000 lights and 400 styles of fixtures, the Bureau reaches into most every neighborhood and street corner of the city. It's one of the largest municipal street lighting bureaus in the country.

As such, the Bureau receives no set City funding. Funding for its operations comes from three main sources: assessments paid by residents; fees paid by developers; and various other governmental and private sources.

"Los Angeles is lucky that so many private developers have been paying for lighting systems since the 1920s," said Bureau Director Phil Reed. "The City didn't require it of developers until the 1950s."

Who knew that when Thomas Edison flicked the switch on one of seven 150-foot-tall carbon arc lamps towering over downtown Los Angeles in 1882, it would eventually lead to the modern, efficient and wide-reaching Bureau? In actuality, the modern Bureau was

created by a change in the city charter in 1925. Before then, it was part of the City's Department of Power and Light.

The Bureau works extensively with the LAPD, neighborhood/homeowner associations and chambers of commerce to alleviate what can be safety and security problems.

Currently, about two-thirds of the City has street lighting. Most of the remainder lacks street lighting for two reasons, according to Reed: they can't afford it, or, like portions of Brentwood and rural areas of the Valley, they don't want it.

"The Bureau's ultimate goal is for every street in Los Angeles to be lit to modern standards if they want to be.

"A lot of the areas without street lighting are in low- to moderate-income areas. They want street lighting, but they're in older areas built before the City required developers to install street lighting. We're working to help them as best we can. That's our main goal for the future."

The Bureau works with developers to install systems that work for everyone. Sometimes that means the Bureau has to limit what developers can do, but even at that, the City has installed more than 500 styles of light fixtures.

"Developers come to us who want a more unique or different system. We tell them, okay as long as they are willing to pay for it, and as long as it lasts. We want it to last for 40 years."

All to help the Bureau achieve its goal of lighting up the City of Los Angeles.



# What's the Holiday Bug? Can It **Affect Your Financial Future?**

# Enjoy the season, but remember your financial future, too.

It usually starts the Friday after Thanksgiving.

You notice it all around you; people everywhere are "catching" it. You wonder how long it will be until it gets you. It may take a little while, but eventually you get it and it just about takes you out - you've got a bad case of the Holiday Bug.

#### What are the symptoms of "Holiday Bug"?

They vary each year, and from person to person, but generally include: a festive manner, a desire to socialize, a need to give, frequent smiling and kind words. In more extreme cases there are reports of bursting into song, extreme politeness in traffic and manic episodes of decorating projects that begin at 2 a.m. However, the most common symptom is a slight nervousness about getting "everything" done in time.

#### How do I get rid of this bug?

It's simple: Give in. Do it. Go with the flow. There is a reason this bug comes around every year - it's good for you. Once January rolls around it starts to dissipate on its own.

#### But what about that uneasy feeling about getting "everything" done?

Through proper diet and the following exercise you can reduce the anxiety.

First, make a list of "everything." Next,

prioritize that list, using "A," "B" or "C" to determine its relative importance and urgency. Wait a day or two (to prevent exhaustion) and then pull out your prioritized list and calendar. Look for free time on your calendar and start filling in your list items. Make sure that your highest priorities get input first and fall within the soonest openings, or most appropriate times. Be sure to leave a few open times and mark them "overflow" (to prevent hysteria when things are not moving according to plan). Make sure to include "me" time, even if it's an hour a week; you need to give yourself a chance to recharge from the bug.

## So what does this have to do with financial planning?

Everything. Usually personal finances will appear on the "everything" list. Many people have been procrastinating and realize that they need to handle things before the end of the year. The following is a list of items that often appear on the "everything" list:

- Make sure I've contributed the right amount (maximum) to my retirement accounts.
- Review my insurance to make sure it's adequate in light of our current situation.
- Calculate the gains/losses in my investment accounts to determine any last-minute transactions needed for tax savings.
- Determine if I need/want to make any contributions to charity - and what the tax savings would be.
- Find someone to help with my investments since they've taken such a hit over the last few years.
- Create a budget so I know what I should be spending this season.
- Update my financial statement to see if I'm making progress toward my retirement goals.
- Meet with a financial planner to discuss my financial situation.

These are just a few common items. However, most people have something on

# FORMER SECESSION OPPONENTS JOIN HOUSING LOCALIZATION EFFORT

More than 20 former candidates for Valley city office joined Councilmember Wendy Greuel and representatives from the

Los Angeles Housing Department, housing advocacy groups and members of the public in opening the Housing Department's new Valley Community Services Center in Van Nuys.

Jose Roy Garcia, the top vote-getter for the proposed Valley council's seventh district, praised the effort to give Valley residents better access to city services. "This new housing office will directly benefit the Valley's seniors and working families," Garcia said.

The Valley Community Services Center will provide convenient access to an array of code enforcement and rent control-related services. Tenants will be able to file complaints for code and rent control violations. Property owners will be able to pay necessary fees and register their properties under the Rent Stabilization Ordinance.

"This new housing center is about bringing city services closer to our communities," Greuel said. "Valley seniors should not have to trek to downtown Los Angeles in order to file a code enforcement complaint. Valley families should be able to meet the housing inspectors working to address their issues."

The Housing Department's Valley Community Service Center, 6640 Van Nuys Blvd., is the first of its kind in the San Fernando Valley. Initially the office will be open Monday through Friday from 9 a.m. to 4 p.m.

## WHO YOU GONNA CALL ABOUT SERVICE? 3-1-1

To help create a more user-friendly government for Angelenos and dramatically improve accessibility to City services, Mayor Jim Hahn today announced that Los Angeles residents, businesses and visitors can now call 3-1-1 for help with City services.


The new 3-1-1 system allows residents to make "One Call to City Hall" for information and any non-emergency service. Instead of sorting through more than 800 listings in the phone book or having to know which City departments handles a service, residents and businesses now have one easy-to-remember number to access City services.

In this initial phase, the people of the City of Los Angeles can call 3-1-1 from wired telephones, 24 hours a day, seven days a week. Los Angeles customers of Cingular Wireless will soon be able to use their mobile phone to dial 3-1-1 for City services information from anywhere within the City.

Calls are answered 24 hours a day by 3-1-1 Ambassadors who are trained to provide information or refer calls for service to the correct City agency – the first time. However, referrals for specific City services are primarily available during regular business hours when the various departments are staffed to handle the call. City Ambassadors are trained to answer questions in English and Spanish, and 3-1-1 is accessible in more than 150 other languages through the use of language translation services. Additionally, the 3-1-1 Call Center is also equipped to serve the hearing impaired.

According to Chief Information Officer Liza Lowery, "Los Angeles is the largest city in America and the first in Southern California to implement 3-1-1.



# Most Important Holiday Recipe: Keep the Cutting Surfaces Clean

In this issue, I wanted to offer some easy to make recipes for the busy holiday season. At the same time, I want to pass along to you some tips on how to keep your cutting-boards sanitized. No one wants to have to see a doctor during the holidays because you picked up a food-borne illness that could have been prevented. Nothing like a bug to kill the holiday spirit! We've all been there, so let's be careful.

## Cutting Board

**Cleanliness** It is vital

to keep your cutting board surfaces clean to prevent bacterial contamination and avoid developing food poisoning, especially from pro-

tein products (chicken, beef) that have been in contact with cutting boards. Remember to wash the board, your hands, knives, and forks with hot, soapy water. I would not suggest putting cutting boards in the dishwasher because the boards tend to crack and break after a few runs, and it makes it easier for bacteria to hide in those cracks.

However, I strongly recommend an

occasional soaking of cutting boards in a light chlorine bleach solution for several minutes. Use 2 teaspoons of bleach per quart of water. Wash the board after soaking it in the bleach solution.

# Golden-Oven Baked Apples

## **Accidental Death and** Dismemberment

#### Question:

What is accidental death and dismemberment insurance?

> Answer: This coverage provides a benefit in the event of death due to an accident. Examples are an automobile accident or airline crash. Dismemberment means bodily injury resulted in an accident (such as a loss of limb, hearing, sight, speech, paralysis). The member with the coverage on him- or herself will receive the specified sum.

#### **Question:**

How much would my husband get if I die in an accident if I have a \$200,000 plan?

> Answer: If you have an individual AD&D plan and your husband is the person designated by you to receive the benefit (beneficiary), then the full benefit amount will be paid. The death must be such that it was caused by an accident and proof of such loss must be received. The accident must happen while the person is insured and the loss must occur within 90 days after the dates of that accident.

#### **Question:**

Would my beneficiary get the full benefit amount if I lost my foot in...let's say...a camping accident?

# Questions Answered About Dependents, Accidents

rere are more tips to help you with your benefits. This month we're talking about dependent coverage, and accidental death and dismemberment coverage. If you have questions, send them in. I'd love to answer them. Happy holidays from Counselor's Corner!

Answer: This is a covered loss in the dismemberment benefit section for 50 percent of your total coverage. If you have a \$200,000 AD&D policy, you would receive a \$100,000 payment for your loss.

#### Question:

I have a life insurance policy of \$50,000 and an accidental death and dismemberment policy of \$75,000 with the City Employees Club of Los Angeles. If I died in an accident, would my family only get the \$75,000 of accidental death and dismemberment?

> Answer: Both would pay. Your family would collect a benefit of \$50,000 for life insurance and \$75,000 of AD&D for a total of \$125,000. Keep in mind that your life insurance pays a benefit with any type of death (except for exclusions listed in your policy contract). AD&D insurance will pay upon a death caused by an accident.

## **Dependent Coverage**

#### Question:

I have the City Employees Club Term Life Insurance with something called dependent coverage. What is that?

> Answer: Dependent Coverage is a life insurance rider that provides \$1,000 of coverage for children who are over 14 days old but less than 6 months old.

Then it rises to \$10,000 of coverage for children between 6 months up to 19 years of age. The coverage may extend through age 22 if the dependents are full-time students at an accredited educational institution.

#### Question:

How much does this cost me for my son and daughter?

> Answer: It is a flat rate of \$2.40 per month for any number of children you may have. So, even if you have 10 children, each child would be covered and you still only pay \$2.40 per month.

#### **Question:**

What happens if my child is about to turn 23 and is still in school? Can my dependent purchase life insurance through the City Employees Club of Los Angeles?

> Answer: The dependent coverage for that dependent will end when he or she turns 23 years of age.

#### **Question:**

What if my wife and I are both insured under the group policy as members? Can my dependents be covered on both policies?

Answer: No. Dependents may be insured under only one of the member's insurance, but not both. However, dependents may buy an individual policy of life insurance. Speak to a Member Services Counselor for more information.

#### **Question:**

Are stepchildren or adopted children included in the definition as dependents?

Answer: Yes. "Children" includes stepchildren and adopted children who are supported by the member.

#### **Question:**

Who is responsible for ending the premium payments of \$2.40 per month for dependent coverage when my child is no longer my dependent?

Answer: It is the responsibility of the member to notify the City Employees Club of Los Angeles when he/she no longer has eligible dependents.

#### Question:

Are there special conditions for a handicapped or retarded dependent?

> **Answer:** Insurance for a dependent may be continued past the age limit if he or she cannot support him- or herself because of retardation or a handicap. Premium payments will be required. Proof of the retardation or handicap must be sent to the City Employees Club of Los Angeles within 31 days after the child attains the age limit. Insurance will continue for as long as such child remains retarded or handicapped, and meets all the rules for dependents in the group policy, except age limit.
