




One City, Five Halls

ast month's article was a news release by Dr. Judson A. Grenier, Retired Professor of History Emeritus from California State University, Dominguez Hills. The release was an overview of a massive two-volume history of Los Angeles City government to be published shortly. Within the confines of this major work is a section on the history of the five original city halls, featured below, written by Irene Tresun.

Los Angeles City Halls, 1853 to Present



1853 Rocha Adobe City Hall

On April 4, 1850, Los Angeles, with a population of about 1,600 within its jurisdictions, became an incorporated city. The homes of prominent citizens such as Benjamin Hayes and Abel Stearns were the first meeting places of the Common Council. In 1853, the city began leasing space in an adobe on the southern end of town. Traveling south from the plaza on the west side of a dirt road known as Spring Street sat the Rocha Adobe. The building became the first official Los Angeles City Hall under the American flag.

The Jose Antonio Rocha building, across from the present City Hall, was a single story adobe typical for its time, long and narrow with an extended roof over the porch. The adobe housed the offices of the Tax Collector and City Treasurer. A dimly lit room served as the Council chamber, where candles were in good supply in case of late meetings

1885 Second Street City Hall

In July of 1884, the Council approved drawings for a new municipal building. The plans were for the first city hall built and owned by the City of Los Angeles. The building, completed in 1885, sat on the north side of Second Street, between Spring and Fort Street. Its brick and stone façade was crowned with a schoolhouse-style bell tower.

Within two years of completion, the three story city hall had become inadequate to serve the rapidly growing city. Population increased from 11,000 to 50,000. Los Angeles was no longer a dusty pueblo. City hall was sold in 1887 for \$120,000, which assisted in the construction of the new 1889 city hall.

Los Angeles began the 20th century with a population of more than 102,000. In 1912, when it was apparent that William Mulholland's dream to pipe water from Owens Valley, 240 miles away to the City of Los Angeles, was to become a reality, the City Council began plans for a new city hall. By 1920, the population had reached 576,000, and according to Mayor George E. Cryer, 80 percent of the City's offices were in rented buildings. The old city hall completed in 1889 on Broadway was outdated and overcrowded, and its tower had been cut down to half its height, as it was discovered to be leaning in 1918.

The new city hall would eventually cost close to \$10 million for site, construction, structures, equipment and furniture. Special legislation was drawn up to allow the new city



hall to exceed the City's 150 foot height limit, clearing the way for Los Angeles to build a world-class skyscraper. By 1927, keeping with tradition, when the steel skeleton was completed an American flag was placed at its apex, more than 450 feet above the streets below. At that time it was the tallest building in Los Angeles.

1859 Los Angeles City Market and City Hall

In 1858, Jonathan Temple began construction on a twostory brick structure. The Council approved the proposal, and in September of 1859 moved into its new chamber. Located on the east side of Spring Street, and a stone's throw to the north from the Rocha Adobe city hall. The building was officially called the Los Angeles City Market and City Hall. Its large clock tower, with a clock facing four directions, boldly rose above the town's predominantly single story adobe skyline.

In 1869 the County purchased it and gradually the building became known as the Clocktower Courthouse. Despite the new owner and the new name, the Common Council would continue to meet on the second floor. Later. Mayor Cameron E. Thom declared the need for the government to have its own city hall.

1889 Fort Street City Hall

In 1889, a much needed city hall was built that would serve the City's present and future needs. The Romanesque revival structure was constructed of red sandstone, steel and wood, with a tower that extended well above the downtown skyline. The location on Fort Street between Second and Third Streets was to showcase the building and emphasize its importance. The Mayor's office and the Council chamber were on the second floor of the tower section.

The City, having spent more than \$300,000 for construction was able to provide space in the building for almost every municipal department, including the City's library. The Fort Street city hall remained in existence until 1929. In 1890, Fort Street was renamed Broadway.

On Friday April 2, 1928, the new city hall opened its doors to the world, establishing itself as the seat of local government. The building was dedicated April 26, 1928. The celebration culminated with President Calvin Coolidge touching a telegraph key at the White House, lighting the Charles Lindbergh Beacon atop the pyramid roof of city hall.

In 1986, almost 60 years after dedication, Project Restore was established under Mayor Tom Bradley to restore and preserve this national landmark. The new agency believed the changes could be realized through an energetic partnership of the community's public and private sectors. By 1998, City Council adopted Project Restore's Master Plan for City Hall's renovation. By 2001, many restoration projects were completed. City Hall was rededicated April 26, 2002, 74 years later to the exact date of the original dedication.

Ed Harding, RLACEI President, reports: "As I begin my 11th year as your president, I am fortunate to have some very competent committee chairmen who really do most of the work with little fanfare. They have all agreed to serve for another year: Ken Spiker, Legislative Chair, helps us to keep informed of all legislation that concerns retirees; and Phil Skarin, Publicity Chair, writes this monthly column and edits the RLA-CEI Newsletter. With the passing of Larry Jones, Phil is now the senior member of our Executive Board.

"Hal Danowitz and I have been invited to a

conference on Retirement Systems sponsored by L.A. County in Long Beach March 21 – 25. I will be on a panel to discuss the relative merits of a defined Benefit Retirement System vs. a Defined Contribution Retirement System. The Governor is trying to get legislation passed to require all public employees retirement systems to use the Defined Contributions type. This would dramatically change the L.A. City Employees Retirement System. Stay tuned.

"I urge all members and their spouses to save the date of Thursday, April 14, for a Membership Meeting at the Van Nuys/Sherman Oaks Senior Center at 1 p.m. You can come at noon for a free chicken lunch, but only if you make a reservation by calling one of the officers on the Retirees Helplines by April 7. There will be speakers who will tell about

the status of legislation affecting retirees and their spouses. Many valuable door prizes will be passed out.'

Legislative Update: Ken Spiker, our elected Commissioner to the LACERS Board of Directors, reports the LACERS fund has leveled off at \$8.4 billion and remains healthy.

In regard to the Board's earlier conflict of interest problem, Ken reports the Board had previously directed DFA, the small cap investment firm managing approximately \$319 million for LACERS, to sell the investments within 120 days. All of the investments were sold and LAC-ERS recovered approximately \$319 million, which now has been reinvested in other holdings. According to LACERS staff, no fee was charged for liquidating the original assets.

Lastly, it was previously reported that the City's actual contributions to LACERS for Fiscal Years 2003-04 and 2004-05 were less than required because of inaccurate assumptions used by the prior actuary. This produced a Net Pension

Obligation (NPO) estimate of \$41.6 million. The LACERS Board has approved spreading the NPO over a 15-year period with the first payment to be included in the City's contribution amount effective July 1 2005. On Jan. 11, the City Council received and filed the City Administrative Officer's report on this issue, which recommended accepting the Board's action to spread the NPO over a 15-year period. The matter will again be considered when the Mayor and City Council process the annual contributions to LACERS.







Rory, one of the

Bureau's emergency specialists , was on site, briefing City officials that night, including Mayor Jim Hahn, Councilmember Tony Cardenas and Bureau of Public Works Commissioner Yolanda Fuentes Sunday night when he returned to work at the sinkhole site.

He walked away and stood near the edge of the sinkhole. The ground gave way, and he fell in.

It remains unclear exactly how Shaw fell into the sinkhole. LAFD officials are continuing their investigation at press time.

Cardenas was quoted as saying that he saw Shaw began to cross the street in deepening water, and then, "he just disappeared."

Within minutes, Cardenas was quoted as saying, LAFD rescuers arrived on the scene, but they were not able to rescue Shaw.

"My heart and prayers go out to Rory's family, friends and co-workers, and I extend my deepest sympathies," Mayor Hahn said. "I have ordered all flags at City facilities to be flown at half staff in his honor." Mayor Hahn also said that counseling was to be available for City employees who knew Rory. Rat a memorial service held in City Council chambers Feb. 24, approximately 400 people came to remember him.

In a crisis, civil engineer Rory Shaw was the go-to guy. Even if the call came in the middle of the night or on his day off, he would respond.

Rory, director of the City's Emergency Sewer Repair Division, was killed Feb. 20 in Sun Valley when the ground gave way while he was helping to repair a sinkhole in Tujunga Avenue in Sun Valley.

"His life ended tragically because he was trying to save a street," his sister, Leslie Botti, said during the two-hour memorial.

"Do not play the what-if game," she was quoted as saying. "It was an accident."

Born in Aurora, Colo., Shaw grew up in Michigan and graduated from Michigan State University in 1979. He served in the Navy until 1984, working on nuclear power and classified assignments.

He went back to school to obtain a civil engineering degree and then embarked on a 14-year career with the Los Angeles Public Works Department.

"I think it's an honor for all of us to be City employees when we look at employees like Rory Shaw," said Hahn. "His memory is going to serve as an inspiration to all of us. Maybe when we're tired, maybe when we think the job is too difficult, we can think of Rory, and maybe we can also go beyond the expectations."

Shaw's family has set up a scholarship fund with his alma mater, Michigan State University. Those who wish to donate should make their checks out to the university, and include the designation, In Memory of Rory Shaw.





China on Parade

The 106th annual Golden Dragon Parade snaked its way through Chinatown Feb. 12 in the Year of the Rooster.

The parade drew a number of important participants, including the LAFD, Mayor Jim Hahn and several City Councilmembers.

Here is a history of the parade, taken from the Chinese Chamber of Commerce Website:

More than 100 years ago, the Chinese community began to participate in the parades of the City of Los Angeles. In 1898, the Chinese lion and dragon procession were regarded as one of the most beautiful units in the City's annual La Fiesta parade. The Chinese community was applauded for its contribution to the celebration.

The Fiesta committee immediately requested the Chinese community to permanently join this annual event. The Chinese Merchants Association organized and sponsored the lion dance procession in addition to one or two floats. The group also arranged for the use of a dragon from the Chinese community in Marvsville, Calif. Subsequently, they raised \$1,500 to acquire a dragon that required 25 men to maneuver. Their units were always considered the main attraction at the Fiesta parade and had always drawn a very enthusiastic and excited crowd.

In 1956, the Chinese Chamber of Commerce of Los Angeles (formerly the Chinatown Chamber of Commerce) joined in the celebration. New dragon heads were imported from Hong Kong, and local family association members were hired to perform the cultural dances. In the early 1960s, the lion and dragon dancers would visit every Chinese business along the parade route. Funding for the parade included fundraising dinners and door-to-door solicitations to gather support from Chinatown businesses.

After the Vietnam war in 1975, Indo-Chinese refugees poured into the United States and soon became active in our community. Local family associations, Buddhist temples and communitybased organizations mushroomed, and the parade became a focal point of community participation.

Since the 1970s, the parade has had a number of celebrity grand marshals, including Bruce Lee, David Carradine, Haing Ngor and Lindsay Wagner. The parade, originally a Friday night fixture, was moved to Saturdays to accommodate more viewers and participants.

Since the mid-1980s, the Golden Dragon parade has expanded to include almost two dozen floats, multiple marching bands, government officials, dignitaries, entertainers, local business leaders and cultural groups. The parade's theme emphasizes ethnic diversity, Chinese culture and exposure to Chinese businesses. The parade continues to be a rich and diverse experience for Angelenos of all ages and ethnicities.

LAPD Sees Some Reorganization

■ The following is LAPD Chief William Bratton's monthly message distributed in early February via the department's online listserv. Note: This message was developed most likely before the incident involving 13-year-old Devin Brown.

The Chief's Message

With 2004 now behind us, the men and women of the LAPD have much to be proud of. They were successful once again in saving lives and making the streets of our City safer. Now it is time to set new goals for the new year,

and optimize and capitalize on the momentum of the past two years. Because of their hard work, and ability to do more with less, the command staff and I feel that this Department has the capacity to achieve a stretch goal of an additional 10 percent reduction in Part I crime in 2005.

This is a stretch goal, similar to last year, and is based on the assumption that the LAPD will not realize any significant increase in personnel resources in 2005. Should there be a change in available resources, either an increase or decrease, this stretch goal will be adjusted accordingly. As part of the effort to realize this 10 percent crime reduction goal, working with the recommendations of the senior command staff, we have further refined and reorganized the Department's structure to make it more efficient, coordinated and focused. We have combined certain commands to eliminate duplication and expedite operations both internally and with the City's administrative structure.

The largest change in the Department's organizational structure is the elimination of Human Resources Bureau with a large share of its units being reassigned to the Office of Support Services, which remains under the command of Assistant Chief Sharon Papa. These include Personnel Group, Training Group, Behavioral Science Services, and the Ombuds Office. Risk Management Group will be reassigned to Consent Decree Bureau and Employee Relations Group will be added to the responsibilities of the Chief of Staff. The Chief of Staff will also be responsible for the Use of Force Review Section. By eliminating Human Resources Bureau, it will free up First Assistant Chief Jim McDonnell to become the new Chief of Staff, and will allow him to work more closely with me as we continue to

fight for more resources. It will also allow Deputy Chief Mike Berkow to devote his full attention to commanding the Professional Standards Bureau. I very much appreciate Chief Berkow's willingness over the last eight months to perform successfully what amounts to two full time functions.

Another major change is in the Office of Operations, continuing under the command of Assistant Chief George Gascón. Office of Operations will assume the responsibility of Jail Division. Under Operations, we will look for efficiencies that help us to cut the time it takes to book detainees. The ultimate goal is to get police officers back on the streets more quickly to do what they do best – fight crime.

Another change in the Office of Operations will be in the Detective Bureau, which remains under the command of Deputy Chief Gary Brennan. The Organized Crime function will now become its own Section and will be moved to Major Crimes Division. Major Crimes is under the newly renamed Counter Terrorism and Criminal Intelligence Bureau (formerly Critical Incident Management Bureau) under John Miller. Vice Division will remain in Detective Bureau.

LAPD Chief William Bratton

As I mentioned, Assistant Chief Sharon Papa, who heads up the Office of Support Services, will assume command of a large portion of the human resources related duties. Commander Mike Bostic will serve as her Executive Officer and will oversee Planning and Research Division. Personnel Group will fall under Administration and Technical Services Bureau, (formerly Fiscal and Technical Services Bureau) aligning it more closely with the budget and finance component. Ninety-six percent of the Department's budget supports the personnel function. By combining these two areas, we will be able to operate more efficiently with City Hall and the City Administrative Officer. Additionally, Records and Identification Division will move to Information and Communications Services Bureau.

This reorganization supports our 10 percent crime reduction goal this year and is consistent with the Department's 10 percent crime fighting formula for success; 10 percent of the suspects commit 50 percent of the crime, 10 percent of the victims equal 40 percent of the crimes, 10 percent of the places are where 60 percent of the crimes are committed. By streamlining our systems and structure, we will continue to focus our limited personnel on these repeat offenders, victims and problem locations.

With the additional refining and reorganization of the Department, I am confident the men and women of this organization can continue to reduce crime, prevent terrorist attacks and fully implement the Consent Decree. We are working to enhance the quality of life for everyone who lives, works and visits the City of Los Angeles.



Officer Scotland, **Rest in Peace**

On Feb. 5, the Harbor Department Port Police Division held a memorial service honoring the career of Port Police Officer Michael Scotland. Officer Scotland passed away Jan. 27, following a courageous battle against leukemia. Fellow officers, coworkers, family and friends gathered in the Harbor Administration Building Board Room to share their memories of Michael and remember the man whose humor and caring touched so many people.

Officer Scotland began his career with the City of Los Angeles' Harbor Department Port Police in July 1977. In May 1981 he received a commendation, along with Officer Ernesto Paz, for rescuing a man from drowning who had severely injured himself when he fell from a wharf into the water. Shortly thereafter in August 1981, Officer Scotland along with other Port Police Officers, were commended for rescuing persons from a capsized sailboat and for righting the vessel. Officer Scotland would go on to receive four commendations for his police work from the Harbor Department and two letters of appreciation from the Los Angeles Police Department.

Mike's caring was best described by his neighbor, a little girl whom he called Princess, who shared a story how Mike would watch over the neighborhood children sharing his time with them and how he would fill the air on her bicycle tires. But the most lasting memory she has is when she was leaving after having visited Mike in the hospital of him smiling at the window blowing "thousands of goodbye kisses to her."

The memorial was presided by LAPD Chaplain Ed Beardsly; the Port Police provided the Honor Guard. Following the memorial in the Board Room the gathering moved to the Harbor

Administration Building Patio where the LAPD Emerald Society bagpipes and drum corps performed Amazing Grace. The Port Police Honor Guard provided a Rifle Salute for Officer Scotland followed by a bugle rendition of Taps by LAPD Officer Amy Wong and a flyover by the Port Police Air Support helicopter.

The family of Officer Scotland wish to thank the many people and groups who organized and participated in the very successful Bone Marrow Donor Drive held at the


2004. The outpouring of support touched the life of Officer Scotland and the many people who will benefit from the drive.

Curiously Cute ... And Against the Law

No doubt a number of *Alive!* readers saw the story on the news about the serval – an exotic cat that escaped in the Laurel Canyon area of West Los Angeles a few weeks back. There was a lot of media interest in the animal – because the cat is so exotic and also because of the danger it presented L.A.'s surrounding neighborhoods.

Although the serval had been raised as a pet (it had a collar and tag) and although it had been declawed (a painful procedure involving the permanent removal of an animal's nails), it was still a large predatory animal with enough sharp teeth and "wild" in it to endanger small children and pets. Even our own Animal Control Officers had to be very cautious handling the exotic cat.

So, what is a serval? It looks much like a bobcat. It is around three feet long and a foot and a half tall. The serval comes from Africa and is exotic to California. It looks almost comical with a head that's almost too small for its striped and spotted body. Still, this wild feline is graceful and is a sight to behold.

The serval story did come to a good end. Our department set out humane traps in the area where the cat was first seen and while it did not take the bait, it did manage to survive on its own. There were serious concerns that the serval might not be able to defend itself from other predatory wildlife because it had been declawed. Sitings were reported on and off throughout the exotic cat's trek from West L.A. to Studio City. Finally, a resident called the East Valley Shelter to report a large cat in her backyard. L.A. Animal Services immediately dispatched Officer Angela Jackson - a petite (and brave) Animal Control Officer who was able to single-handedly immobilize the scared creature using an Animal Control Device (a stick with a loop on the end). No one was hurt and the serval is doing well in a wildlife preserve where it can live out the rest of its days in comfort with other servals.

Other servals? Well, yes. Unfortunately, there are some very smart people who feel it's a good idea to smuggle, breed and keep these exotic animals as pets – you know, a good showoff and conversation piece – until the animal escapes and endangers the community.

To these folks, let it be known: It is against the law to keep predatory wildlife as pets. The Department of Fish & Game and the Department of Animal Services both require special wildlife and exotic permits to ensure that (1) exotic wildlife is treated well and kept in a suitable environment, and (2) that keepers of wildlife have the ability to keep the animals under control at all times and make sure the animals do not escape. There's another law involving predatory wildlife that many choose to ignore: It is against the law to feed any predatory wildlife. Wild animals do not like to be around humans (we too are predators). However, when some wellintentioned person begins to feed wildlife, there is a tendency for the animal to lose its fear of man and become quite comfortable around our species. Animals accustomed to human handouts become dangerous not only to the feeder but also to the feeder's neighbors as well. This



could spell disaster for both people and the wild animal, causing possible harm and death to humans and condemning the wild animal to capture and death.

For safety, it is best to discourage wild animals such as servals, coyotes and bobcats from coming around your property. Here are a few ideas:

- Clear your area of excess vegetation to remove secluded hiding places.
- Do not leave pet food or water outside when your pet is indoors.
- Pick fruit from trees as soon as it ripens. Pick up all fallen fruit.
- Use fencing at least six feet tall with the bottom extending 6 to 12 inches below ground level. Add an angle at the top of the fence facing. The angle should face outward at a 45-degree angle and should be at least 16 inches wide.
- Restrict feeding birds and squirrels. Predatory wildlife is attracted to these small animals as they are to the pets (and small children) in your yard.
- Keep small children and pets indoors.
- Never leave small children unattended.
- Should an animal come around, use noise and motion activated deterrents to make the animal uncomfortable. Try an air horn, a motion activated sprinkler or even an outdoor radio set to a news or talk station.

If confronted with predatory wildlife, make yourself appear as large as possible and move away slowly.

For those who are curious as to the owner of the serval, he has signed the animal over to L.A. Animal Services. He is being very cooperative. Still, he does face criminal charges and, while that too makes a good conversation piece, I have a feeling our serval owner would rather it not be the case. He's also probably realized that keeping predatory wildlife for a pet just isn't worth the risk.







3 Years Advising The Port

Demonstrating that the Port of Los Angeles and its neighbors can work together productively, the Port Community Advisory Committee (PCAC) recently celebrated its third-year anniversary.

A standing advisory committee of the Board of Harbor Commissioners, the PCAC was established in 2001 by Harbor Commission approval in support of Mayor James Hahn's vision for the Port to work more closely, in a consensus-building fashion, with community members and other Port stakeholders. Comprised of more than 35 members, the Port Community Advisory Committee panel has representatives from local neighborhood councils, homeowner groups, local chambers of commerce, labor, industry and elected officials.

"When I came into office, the relationship between the Port and the community had reached a breaking point, and I knew that we needed to establish a formal channel through which the community could voice their opinions and concerns about Port growth and operations," said Los Angeles Mayor Jim Hahn. "Three years later, I'm glad to see that the Port Community Advisory Committee is thriving and playing a central role in the relationship and interaction between our Port and its various stakeholders."

"Through this collaborative process, the port now has a vehicle for obtaining input on community issues which are researched, studied and put into formal recommendations for consideration by the Harbor Board of Commissioners," added Camilla Townsend, Harbor Commissioner and PCAC Co-Chair. "This is an invaluable process that takes time and commitment. I am grateful to the PCAC members who give so much time to this endeavor."

"It has been a challenging three years, but great learning experience. The community Port and maritime industry have benefited greatly from the process," said Jayme Wilson, PCAC Co-Chair and local business owner PCAC member Joe Gatlin adds, "The Port of Los Angeles has become an environmental and economic leader in our community. The new era of trust and transparency from the Port is something our community has always wanted and needed." The Port Community Advisory Committee meets on the third Tuesday of each month at the Sheraton Los Angeles Harbor Hotel, 601 S. 



O'Mally's Potato Cakes

INGREDIENTS • 1/4 cup butter

- 6 to 8 ounces all-purpose flour
- 1/2 teaspoon sea salt
- 1/2 teaspoon baking powder
- 3 cups freshly mashed pota-
- toes (with milk)
- 1/2 teaspoon dill weed
- (optional)

DIRECTIONS

Cut butter into flour until it forms large granules. Add sea salt and baking powder, mix well. Mix in potatoes. Knead for a few minutes. Roll out onto lightly floured board with floured rolling pin. Cut into 2 rounds. Cook on a dry griddle or skillet until brown on both sides.



Speaking the Truth: Ecumenism, Liberation and

Black Theology James H. Cone Orbis Books 154 pages

Non-fiction James Cone poses some very interesting thoughts on the topic of Black Theology. This book is full of interesting and refreshing ideas about the role of the Gospel in our time.

Cone poses the idea that black theology, as opposed to what we consider Western theology, is about liberation. He

equates the Gospel to liberation theology and insists that failure to see the message of liberation at the center of Christian thought risks humans falling into what Karl Marx called "the opium of the masses."

With this thought in mind, it is easy to see how sometimes religion has been used to commit some of the greatest crimes against humanity in history. For example the bible was used to justify slavery.

Cone points out that the core message of the Old and New Testaments is one of liberation. In the Old Testament, the main story is the exodus of the enslaved Hebrews out of Egypt and secondly from Babylon. In the New Testament, God is born as a poor man who gives a message of freedom. Jesus lives as a poor Jew under the oppression of officials and Read a great book lately? Tell your fellow Club members about it! the Roman Empire. Jesus is captured and killed as a prisoner. In the end his resurrection proves him victorious over oppression. Jesus gives a voice to the poor, the sick, and the oppressed.

Cone also points out the social impact that the black church has had on the black community, because it was only on the day of worship, that people had a chance to experience themselves as something entirely different and perhaps opposite to what they experienced the rest of the time, either during the slavery period or during the years of oppression that followed. It was during their worship time that as cone puts it: "Janitor became Deacon, maid became Stewardess.

These experiences gave people the hope that carried them through difficult times. It was

something to look forward to, a time to talk about suffering without having to live it at that particular moment, or feel limited by it, a time to feel liberated from the oppressors and to experience and acknowledge each individuals own divinity.

Cone says that the "culture of the oppressed should be the primary source for explaining the meaning of the Gospel for our time." When we fail to do that, we risk falling into the old domination model rather than a model of partnership. We risk repeating the same mistakes. It's a good book to read; it may be a little difficult to find, but it can be ordered online. It's certainly one that will spark ideas and fuel dialogue


