





# Baby Chimps!

# Zoo welcomes three to its chimp family.

Over the past year, the L.A. Zoo has had three baby chimpanzees born. The first named Zuri was born to mother Regina on July 23, 2012. On March 8, 2013, Yoshi gave birth to Uki, and finally on April 22, Gracie gave birth to an as-yet unnamed infant. All three youngsters are females. The birth of Uki represents an important milestone in the chimpanzee's troop as she is a fourth generation birth within the Zoo's troop.

Uki's mom, Yoshi, was born at the Zoo on July 2, 1990, her mother, Regina, was born at the Zoo on October 23, 1983. Finally, her mother, Pandora, was born at the Zoo on March 5, 1967, less than a year after the Los Angeles Zoo opened. Pandora is one of the Zoo's oldest residents and as the matriarch of the chimpanzee family has seen the chimp's zoo environment change from barred cages to a concrete grotto to the opening of Chimpanzees of Mahale Mountains in 1998.

All three youngsters are being raised with their mothers on exhibit and in the company of the rest of the adult females. The infants are slowly being introduced to the rest of the troop. Shaun, an adult male, was specifically chosen as the first male for these infants to be introduced to as he has shown patience with past youngsters.

Growing up with adult males is a natural part of life. The role of the male is to protect the troop and in some cases settle differences between female chimpanzees.

The Zoo houses a total of 17 chimps in a complex troop within Chimpanzees of Mahale Mountains. The animals are managed in a

fission/fusion manner, similar to how chimpanzees live in the wild where the troop splits off into sub-troops in various intervals. The exhibit features two separate outdoor habitats – the main habitat includes vegetation, boulders, a stream and climbing opportunities. The second exhibit area is referred to as the "penthouse," a mesh-covered structure featuring ropes, ladders and swings that is situated on top of the chimp's indoor sleeping quarters. Chimpanzees are native to the forest of Africa and are an endangered species threatened by challenges including deforestation and the bushmeat crisis – commercial hunting for the meat of wild animals.

The Zoo participates in the Chimpanzee Species Survival Plan (SSP). The SSP serves 35 zoos across the United States to help guide the management of the chimpanzee population. Currently there are 245 chimpanzees in Association of Zoos and Aquariums (AZA) accredited zoos. L.A. Zoo is also involved in the SSP programs for two other species of great ape, which are also endangered, the orangutan and gorilla.

The Los Angeles Zoo and Botanical Gardens is in Griffith Park at the junction of the Ventura (134) and Golden State (5) freeways. Admission is \$17 for adults and \$12 for children ages 2 to 12. 

"Songs in the Key of L.A." is the first in a series of collaborations between the Library Foundation and the Los Angeles Public Library to mine the Library's vast special collections. The project, curated by a research team led by USC Annenberg Professor Josh Kun, explores a portion of the Library's sheet music collection, which, according to Kun, is the world's only library collection of Southern California sheet music. Through a comprehensive anthology, new recordings, documentaries, a special exhibition at Central Library, an ALOUD program, a free concert with Grand Performances and more, the Library and Library Foundation will bring the Library's sheet music collection to light for contemporary reflection, offering an opportunity to explore the history of Los Angeles through its sheet music.

lished by Angel City Press, Songs in the Key of Los Angeles tells the story of Los Angeles through its songs. Featuring the elaborately designed covers of more than 100 pieces of vintage sheet music, the unprecedented anthology offers a rare musical window into Southern California history-from California lullabies and Los Angeles waltzes, sunshine rags and sunset serenades, to emerging West Coast jazz and the legacy of Mexican folk traditions.

#### **About the Sheet Music Collection**

The Central Library's Art, Music and Recreation Department houses a large collection of printed sheet music ranging from classical, popular and folk songs to musical theater and jazz.

The collection includes an orchestrations collection of more than 2,700 separate works and individual parts and sheet music for more than 130,000 songs, available in songbooks and as individual sheet music. The individual sheet music spans the genre's hevday from the 1850s through the 1950s, as well as later work up through the 1990s.

A portion of the library's collection covers the period of L.A.'s growth from remote outpost into sprawling metropolis and provides a rare window into early Southern California music history. This specific sheet music spans genres from pop to jazz. Mexican folk to blues, includes songs about L.A. and Southern California, features key regional songwriters and personalities and many were an integral part of Los Angeles' music industry at the turn of the 20th century.





# Beginnings of A 'Beautiful City'

The creation of the Cultural Affairs Dept.

I find it endlessly fascinating that, in almost every community, there were some people who were visionaries. I mean people who could see far enough ahead of themselves to a future horizon and could express desires or concerns that reveal themselves years or decades later. This is one of the great treats of being a historian and an archivist. Contrary to the public perception of our City as being shallow or vapid, we have had our share of citizens who believed in a greater Los Angeles, and many of their ideas continue to resonate in our own time.

Let's take the issue of billboards as one example. The concern of oversized signage, whether traditional or digital, is expressed as a quality of life issue as they affect people who live nearby and are exposed to them every day. There is also a public safety component, as these displays may lead to greater risk of distracted drivers and the attendant damages to life and property. The billboard problem in 2013 is not going away anytime soon, with or without the digital signage that seems to be discussed most frequently at present.

Would you be surprised to learn that a citizens' group formed in 1903 expressed concerns about a variety of issues that are not out of place in today's debate over aesthetics? You shouldn't be, since our Archive has many commission records for some of the most influential people living in Los Angeles. Our article subjects not only considered what could be done, they also found ways to make them happen. What began as the Public Arts Commission was established by the Los Angeles City Council on Nov. 2, 1903 with the following duties as reprinted in the City's annual report for 1904: "[The commission will] work for the gradual elimination of ugliness from conspicuous parts of the city."



to reduce the pole menace in residence districts" and "study methods used elsewhere to reduce the bill-board nuisance." The commission also considered actions to transform the community with ideas including "encourage the planting of shade trees along the residence streets" and "pass upon plans for public buildings and other public undertakings from the point of view of art." The final duty of the commission was probably the hardest: "To help arouse public sentiment in favor of a beautiful city."

City Hall on Broadway every first Tuesday of the month. They were semi-official, meaning they had an advisory role but no real power until they proved their usefulness and could be incorporated into the City Charter and become a real force for change. The commission recognized that its only real ability was to "extend its moral influence in furtherance thereof, looking principally to the various legislative and executive bodies of the city government to have [recommendations] carried into effect." So while the commission was limited in actual power, they were free to express ideas for a better Los Angeles that sought to increase government efficiency and eliminate official corruption.

The Commission foresaw the need for an art gallery owned by the City and which would be home to paintings, sculptures and art objects donated by private citizens. A museum for "the great mass of archaeological specimens which could be collected in this Southwestern territory" was another goal. The public library was located on the third floor of the very specific idea of having the walls of reservoirs, bridges and light poles to be stained or painted green.

The commission also urged the enforcement of pre-existing ordinances dealing with the height of billboards, placing signs on bridges, throwing of paper in the street and the smoke nuisance – the smokestack variety as opposed to smoking tobacco (that is a whole story unto itself). While they had nothing to do with the passage of these ordinances, the commission lent its voice against the neglect, if not outright abuse, of the laws already on the books.

What made the Municipal Arts Commission so powerful when they did become a legitimate City department, after charter reform in 1911, was because there was always an architect among the leadership, going back to original founding member John Parkinson. His company, Parkinson and Associates, built the Memorial Coliseum as well as other buildings and landmarks. Other respected professionals in those early years included Fred W. Blanchard,

builder of the Hamburger Department store building the largest steel frame construction of its day - before it was renamed the May Company building. Edwin Bergstrom was a partner at Parkinson and Associates and two of his legacy projects were the Pasadena Civic Auditorium and the Pentagon in Washington, D.C. So the men involved in the commission had clout and clearly knew how to get a project done.

Once the commission became a required party in the design and review process, the city would never look the same again. The present day City Hall, the Central Public Library and Union Station would have been built eventually, but the impact of the Municipal

The goals of the commission – the name was changed to the Municipal Arts Commission in January 1905 – were as lofty in nature as the resources extended to them by the City were sparse. They received no funding for time or materials spent in their meetings, but they did have access to a meeting room in the crowded

City Hall and overcrowded, so the commission urged the city to "do all in their power to build for Los Angeles a Public Library building worthy of the city and the fine library it would contain." Their ideas ranged all over the map from the generic request for a library building to Art Commission was a part of what those landmarks have become and why we remember them.

If you're wondering whatever became of this progressive department, it is known today as the Cultural Affairs Department and includes the Cultural Heritage Commission, which devotes much of its time to preserving much of what the founders inspired.

What became of some of the other great ideas from the 1904 commission? The

art gallery that they suggested was based on the idea that the City would be an owner of art works. Los Angeles does have an extensive collection of art in government offices, the Central Public Library as well. But that's another story for another time.

Det. II Solomon began his City service in 1974,


when he entered the Los Angeles Police Academy. Solomon excelled in his training and was assigned to patrol in North Hollywood.

#### **Report – Pension** Law and Policy by Michael Karsch

As the nation, state and our City of Los Angeles seem to be slowly improving economically, many of the fiscal problems that impact the public pension systems are becoming less foreboding. But the State of Illinois leads the country as the lowest graded state from the credit rating agencies, Standard & Poors, Moody's Investors Service and Fitch Ratings. The State Legislature has failed three times in the last 12 months to resolve the dismal outlook (in August last year, this January, and last month). According to Bloomberg, Standard & Poors has given several downgrades to Illinois, reducing that state to the lowest credit rating for a state

Illinois public pension systems (there are five) are the worst funded at 43 percent, meaning liabilities at almost \$100 billion. The State Senate and State House have collided again and again with different reform packages making different kinds of cuts in benefits to employees and retirees; both are Democratcontrolled, as is the Governor's Office. Bloomberg reports that investors in public debt demand 1.4 percentage points of yield over AAA bonds to own 10-year bonds from Illinois. Another report on nationwide pension plans by state govern-

ments by PlanSponsor.com says that reducing or eliminating costof-living adjustments (COLAs) are one way to reduce liabilities. The report says that elimination still leaves most state plans with roughly \$1.5 trillion less than needed. Some states, such as

also faced lawsuits for reducing their COLAs.

Our City of Los Angeles is finishing this fiscal year in good shape. The CAO reports that the City ends this year "in a stronger financial position than when it started... 2012-13 has proven to be the turning point for the City on its road to recovery." Obstacles remain for the City, namely the proposed savings from labor concessions assumed in the budget. This refers to last year's agreement with the Coalition of Los Angeles City Unions for a general wage increase (a COLA) of 5.5 percent in January 2014. The new budget assumes that this agreement "will not be implemented." The CAO is instructed to initiate discussions with labor and will report on progress to the Executive Employee Relations Committee.

#### Cost of Living Adjustment (COLA) for 2013

By May of each year, the Board is required to determine the Consumer Price Index (CPI) for the Los Angeles area in order to provide a COLA to eligible retirees. The Administrative Code states that the COLA cannot exceed 3% annually.

When the CPI is greater than 3%, the difference is "banked" for future years. When the CPI is less than 3%, LACERS can then use available "banked" amounts to increase the COLA to the maximum 3%. Just how much of a COLA a retired Member will receive depends on their retirement date and how much is "banked" from previous years.

In 2013, the CPI for the Los Angeles area is 2%. The Board of Administration adopted the costof-living-adjustments for eligible retired members and beneficiaries at their February 12, 2013 meeting. This COLA will be effective July 1, 2013.

# **Cape Verde Island**

oin Grand Circle Foundation and Hal and Evelyn Danowitz in our mission to break down the cultural barriers between Cuba and the U.S.—at a pivotal moment in history for the people of Cuba, who are in the midst of major government reforms.

We will center our journey around three Cuban cities: the bustling capital of Havana (5 nights), including both 3 nights in the historic Old Town and 2 nights in the vibrant, downtown Vedado neighborhood; the harbor town of Cienfuegos (2 nights), and the colonial gem of Trinidad (3 nights). Throughout our journey, we will focus on meaningful cultural exchange with the people of Cuba—who you'll find to be warm, welcoming, and eager to interact with Americans. It's a rare, authentic view of daily life in Cuba today.



Evelyn and I took a 38-day trip, which bincluded four days at the Botlierskop Safari Resort near George, South Africa; a 28-day cruise on the *Ocean Princess* from Cape Town, South Africa, to London; and four days in London at the end. Don and Myrna, our cousins, took the cruise with us.

The itinerary was as follows: Cape Town; Lüderitz and Walvis Bay, Namibia; Cotonou, Benin; Lome, Togo; Dakar, Senegal; Mindelo, Cape Verde Islands; Santa Cruz de Tenerife, Canary Islands; Casablanca, Morocco; Cadiz, Spain; Lisbon, Portugal; Le Havre, France; and Dover, England.

As we continue the story, our ship docked at 7 a.m. at Mindelo, Cape Verde Island. We were about 300 miles west of Dakar in the Atlantic, but the prevailing breezes were from the east and were considered sub-Saharan. The islands had been in a drought for the past few years. This seemed cyclical in the archipelago's history. We took a half-day tour of the island that



We took a city and cultural tour. The bus held about 30 people, but there were only 18

of us plus the guide and driver. The bus had

produce market, then the town square. This island had a population of 80,000, of which 90 percent lived in the city. The town is a little like New Orleans, with brightly colored building with balconies and a lot of metalwork. We visited a handicraft museum, which had some interesting pieces. Evelyn bought a magnet. Of the six West African countries that we visited, this was the first magnet since South Africa. Our last stop

> was out of the city at a resort beach, about a 25-minute ride over a cobblestone road. We had a wine tasting excursion and were entertained with some local dancing at a venue that is the site of a music festival put on every August, which attracts more than 50,000 visitors. In addition to using some vacation homes, the festival-goers pitched tents. Sounded like Woodstock. The tour

afternoon, so we had the ship to ourselves in the morning. Evelyn and I worked out and then had breakfast with Don and Myrna. We then played party bridge for a couple of hours. The ship was really deserted, especially the fitness center. It was like having a giant yacht all to yourself.

Cape Verde is a group of 14 volcanic islands, nine of which are inhabited. When the Portuguese first came here in 1456, there were no inhabitants. The island received its independence in 1975 from Portugal. The official language is Portuguese, but a Cape Verdean Creole is also spoken. was fun and entertaining. We got back to the ship a little after 5 p.m., sat in the Tahitian Lounge and had a drink as the ship sailed.

We had dinner in the buffet and called it a night.

We had been getting hors d'oeuvres delivered to our cabin every day on this cruise (and the previous cruise, too). Sometimes we didn't eat them, and I had the room steward take them away. 

#### The Trail

The Buck Gully is a natural, coastal canyon between Newport Beach and Orange County. The canyon is bounded by urbanized areas, including single-family residences, roadways, and the Pelican Hills Golf Course. The watershed draining into Buck Gully encompasses about 1,200 acres and includes portions of the San Joaquin foothills. The ownership of the canyon has changed from the Irvine Company, to the county, and finally the city. Irvine has always had a history of protecting, conserving and maintaining valuable open space areas that define the city's urban form, serve as habitat for many species, and provide recreational opportunities to the public. Activities include docent-led hikes, mountain bike rides, and volunteer programs including trail maintenance and weed removal. The removal of invasive weeds helps maintain healthy habitats for the diverse wildlife population in "social trails."

I really liked this trail. It was clean and well kept, and the new bridges make a big difference. I am sure that, before the bridges were installed, you got your shoes wet and shorts dirty after walking through the creek a few times. Some people might like to get down and dirty; nonetheless the trail was very pleasant.

Everyone in my family loved the trail. I liked the variety of scenery along the way, and the birds were at every tree singing beautiful songs to keep us company. Enjoy the trail.

The first Wellness Fitness Program facilitated by Airport Police Training and Recruitment Officer Cipriano Montes, sponsored by Los Angeles World Airports Risk Management, Human Resources and Airport Police divisions, has concluded. Airports employees from all divisions were given the opportunity to participate in a wellness program that focused on enhancing personal health to improve workplace productivity. The first group of employees participating in the program sweated through their last workout at Dockweiler Beach in Playa del Rey on May 29.

The Wellness Fitness Program was inspired and initiated by Officer Montes and approved by his supervisor, Sgt. Daniel Romo. Airport Police Chief Patrick Gannon, who participates in the program, said, "Like many people, I know the advantages of regular exercise and proper eating habits. However, I have spent a lifetime being inconsistent in practicing what I know to be true." He added, "Since becoming LAWA police chief, I have taken advantage of our wellness program, and I am motivated about taking care of myself to the best of my ability. I would encourage everyone at LAWA to do the same and to take advantage of this great program."

Risk Management and Human Resources approvals were critical and necessary. Airports Nurse Teresa Acuna recommended necessary measures to ensure the safest and healthiest program available for Airports employees. Human Resources Director Paula Adams said, "When Airport Police Officer Montes shared his vision for a wellness program, it was very natural and easy to lend HR's full support.

"The benefit of having a healthy LAWA workforce is the potential increased productivity and reduction in sick time. We have had significant positive feedback from employees enrolled in the LAWA Wellness Fitness Program."

The program began with a one-week orientation, which includes nutritional education, exercise techniques to prevent or reduce injuries and a voluntary submission to get a health checkup for weight, cholesterol, blood pressure, and blood sugar levels.

The next six weeks covered physical training in two weekly 50-minute sessions conducted by Officer Montes. He held six sessions a week providing training both in the mornings and evenings to accommodate the nearly 100 participants in the first set of workout sessions.

At the end of the six weeks, the participants went through a final evaluation to determine progress and receive a certificate of completion. After a two-week break, the participants submitted their names again to start another six-week program.

All Airports employees are encouraged to participate. The next LAWA Wellness Program began June 17. All training is conducted at the new Airport Police Training Facility at 5520 Arbor Vitae, Los Angeles.

# What Affects Car Insurance Rates?

We are often asked by people why they pay so much more for car insurance than their neighbor. It seems strange that two people living in the same neighborhood would have such a wide variation in cost.

Many factors affect your premium. Not all companies use all of these factors, and some might use additional factors not listed here. Your premium may depend on some of the following seven items:

#### 1. Your driving record.

The better your record, the lower your premium. If you have had accidents or serious traffic violations, it is likely you will pay more than if you have a clean driving record. You may also pay more if you are a new driver and have not been insured for a number of years.

#### 2. How much you

use your car.

The more miles you drive, the more chance for accidents. If you drive your car for work, or drive it a long distance to work, you will pay more. If you drive only occasionally - what some companies call "pleasure use" - you will pay less.

#### 3. Where your car is parked and where you live.

Where you live and where the car is parked can affect the cost of your insurance. Generally, due to higher rates of vandalism, theft and accidents, urban drivers pay a higher auto insurance price than those in small towns or rural areas. Some areas are also prone to more lawsuits, higher medical care and car repair costs.

#### 5. Your gender.

As a group, women tend to get into fewer accidents, have fewer driverunder-the-influence accidents and, most importantly, less serious accidents than men. So, all other things being equal, women generally pay less for auto insurance than men. Of course, over time individual driving history for both men and women will have a greater impact on what they pay for auto insurance.

#### 6. The car you drive.

Some cars cost more to insure than others. Variables include the likelihood of theft, the cost of the car, the cost of repairs, and the overall safety record of the car. Engine sizes, even among the same makes and models, can also impact insurance premiums. Cars with high quality safety equipment might qualify for premium discounts.



## 7. The type and amount of coverage.

In virtually every state, by law you must buy a minimum amount of liability insurance. Buying higher limits will cost more, but not proportionately more. So twice the minimum liability coverage will not double the premium. If you have a new or recent model of car, you likely will also buy Comprehensive and Collision coverage, which pays if you are responsible for damage to your car. Comprehensive and Collision coverages are subject to deductibles; the higher the deductible, the lower your auto insurance premium.

#### 4. Your age.

In general, mature drivers have fewer accidents than less-experienced drivers, particularly teenagers. So insurance companies generally charge more if teenagers or young people below age 25 drive your car.

# Life Insurance for Children?

 $M \operatorname{ost}$  kids don't need life insurance, and we hope and pray that they never will. Insurability is probably the most important reason to buy life insurance for your children. It's not just about being able to get life insurance, it's also about how much they'll have to pay to get it. Parents can help their child avoid having to pay substandard rates

when you're a child is a good base for an adult life insurance program later in life. 
In this issue of *Alive!* , Doug tells the harrowing tale of summoning up his courage and his resources once again, and this time making Australia.

In terms of dangers, there aren't many adventures more fraught with it. This time there was sickness; serious frostbite; it to the top. nine deaths (one along the trail ahead of him before he summitted; Doug had to climb around the body, which was frozen on the trail); missed phone connections; bad food; daunting weather; his body going "haywire," a climber who died in the tent next to Doug's at Camp IV; a marriage proposal (not Doug's); a Sherpa who, while indispensable, forgot to turn on Doug's oxygen during a critical part of the climb; nearly dead camera batteries at the top; the final triumph; and on and on. He has a lifetime of stories, and he shares them with fellow Club

The Club is astonished and delighted that Doug would have Members here. remembered to bring a copy of *Alive!* with him, handling it carefully during the two months it took to reach the summit, and then unfurling it proudly upon reaching the top. We thank him for sharing his unmatched experience on top of the world, and we salute him for his courage, his dedication, and his unfailing sense of adventure. - CONTINUED, PAGE 26

# Doug Scarborough recalls his difficult, triumphant ascent to the top of Mt. Everest.

Firstly, I'd like to thank everyone for their sup-port and encouragement on the port and encouragement on this expedition. After I returned from Mt. Everest in 2011, I was not expecting so many people to be interested in my little journey, but I appreciated all the comments and interest that people took in my trip.

Just like my first attempt on Mt. Everest two years ago, I arrived in Kathmandu, Nepal, in early April to begin my two-month climb and acclimation. However, unlike the first time when I went up the north face in Tibet, I was now attempting the south face in Nepal. The south side of Everest was a completely different experience to what I had seen two years ago. This time, we flew in a small propeller airplane from Kathmandu to a tiny airport in the Himalayas called Lukla (which is also the world's most dangerous airport). Situated high in the mountains and on the edge of a cliff, Lukla was an exciting little place to land. Two years ago in Tibet, we were able to drive straight to base camp, stopping in villages to acclimate. This time, it would be a nine-day trek from Lukla till we finally reached EBC (Everest Base Camp) on the south side. As soon as we landed in Lukla, we began the more-than-week-long hike to EBC, which took us through the Sherpa villages of Phakding, Namche, Khumjung, Thyangboche,

Dingboche and Lobuche. Along the way, you get to know your expedition

teammates pretty well, and by the end we were all close friends. A familiar face among our group was David Liano of Mexico. David climbed with me in 2011 but had to turn around at Advanced Base Camp when he became ill with a cerebral edema. He had been attempting a world record by climbing both the south and north side of Mt. Everest in one season. He had attempted this multiple times but something

always caused him to turn around.

Another teammate was Barnabas Borbely of the UK, whose entire reason for climbing Everest was to propose to his girlfriend, Megan Wheeler, from the summit. Megan was waiting back in England clueless of his ambition. Other teammates in the

group came from Argentina, Brazil, Canada, India, Poland and Austria. We arrived at Everest Base Camp on April 12 and began the long and sometimes tedious work of getting in our rotations to acclimate our bodies to the altitude. The first rotation began with a climb through the Khumbu Icefall. This is a large glacier that sweeps down the Khumbu Valley from Camp I. It is a dangerous, foreboding place, and was the reason I chose to climb the north side in 2011. During each rotation, w would wake at 2 a.m. and prepare to climb through the Icefall in the dead of night as it is too dangerous during the day when the sun heats the ice, causing enormous blocks to crash down. To get through the Icefall, we had to cross at least 25 ladders that never looked in the best of shape. One section had three ladders tied haphazardly together, which caused everyone to rush because no one wanted to be stuck on it for

After finishing all the rotations and returning back to base camp, we prepared to make the summit push. My Sherpas and I arrived at Camp II May 18, where we rested for a day and then headed up the Lhotse Face yet again. From there, we needed to wear oxygen 24 hours a day. We arrived at Camp IV on the South Col on May 21, and spent the night in the extremely thin air. The following evening at 7 p.m., my Sherpas and I left Camp IV and headed for the summit. The weather was bad; snow was coming down hard and it was very windy, making visibility nonexistent. As we trudged through the snow, a fresh dead body appeared right in front of us. The body was no more than a day old, and it gave us quite a scare, especially the look on the deceased climber's face. Sherpas are extremely superstitious, and I was nervous this might cause them to turn around. We all unclipped and sidestepped around the body and continued up toward the Balcony and the South Summit.

ecause we had left on such a dismal night, we had the mountain to ourselves. I Bhad always read about long lines at the South Summit and the infamous Hillary Step, but we were the only ones there. By 1 a.m., the weather had cleared up and it became a perfect night. The stars were the brightest and clearest I had seen them, and I saw the best shooting star of my life. One of the Sherpas pointed across to the Northeast Ridge, and I could see headlamps of climbers coming up the north side. It was a surreal moment as I realized that almost two years to the very day I had been on that ridge climbing when we were told to turn around before reaching the summit. The moonlight was so powerful that we could see everything around us, and the views were unbelievable. By 4 a.m., the moon had gone and it was pitch black again.

As the Sherpa in front of me blazed the trail, I looked up to the horizon and through the black. I saw a beam of light cross the entire sky. It was the sun's first light hitting the edge of the earth in some far-off land thousands of miles from where we were

By 5 a.m., we reached the Hillary Step, where we stopped to change out our standing. It was unbelievable. oxygen tanks. The Hillary Step is a large rock that protrudes out of the mountain,

it wouldn't be very hard to climb at all. But the altitude plays havoc on the body and by the time I had climbed to the top, my heart and respiration rate were going crazy. From here, it was only a short distance to the summit, and I could already see the prayer flags adorning the mountain tip.

We reached the summit at 5:40 a.m. May 22. The feeling was incredible. My good friend and coworker, Aaron Shamblin, had asked me to call him from the summit, so I pulled out my satellite phone and made the call. He didn't answer. I called again, with no answer. I

My skin had never crawled so badly, and I just covered my head with my sleeping bag and thought about something else.

amp I was more like a rest stop at the top of the Khumbu Icefall and was used only Con rare occasions when someone wasn't feeling well or couldn't continue on to Camp II. Once we reached Camp II, we stayed for two nights and then headed back to base camp. We had to do a total of three rotations before our bodies had adjusted enough to attempt a bid for the summit. Our last rotation had us climb the Lhotse Face to Camp III, where my Sherpa and I camped for one night with no oxygen. Bad weather was forecast the day my Sherpa and I decided to climb up to Camp III, so we were prepared to hunker down and spend an uncomfortable

"South El Rosario in Baja California: I revisited this wonderfully polychromatic rock art site at Cataviña. It is believed that the paintings were done by Yumano and Cochimi Indians who lived in the area as far south as Loreto. It is impossible to interpret the pictographs, but the fine-rayed disk on the ceiling may be a celestial touch."







"The cirio, or boojum (*Fouquieria columnaris*), is a distinctive succulent found almost only in the southern part of northern Baja. They are said to be something like upside-down carrots. In time, some boojums bashfully bend all the way over to form an arch and nearly put their head in the ground."

"Now *Alive!* reaches Pinguica, another multicolor pictograph site south of Mulegé and inland. The route there is a mostly rocky streambed with boulders and sand."

"San Borjitas, a Baja Great Mural rock art shelter in the Sierra de Guadelupe of Baja California, also requires fourwheel drive. I've done three mule trips to many of the painted sites in the Sierra de San Francisco, but this one has a lot more of the human figures than those in the Sierra de San Francisco."

He was awarded various certificates. Here's the text of a City resolution honoring Ken's career:

Whereas Kenneth L. Huerta is retiring following 32 years of service with the City and Port of Los Angeles Police Department, serving most recently as a Port Police Sergeant; and

Whereas he began his career as a Special Officer with Los Angeles Airport Police, and in 1982 joined the Los Angeles Port Police as a Special Officer, where through hard work and diligence he excelled in multiple capacities, including Sr. Lead Officer and was promoted to the rank of Sergeant; and

Whereas he has maintained a high and ongoing standard of training throughout the entire course of his law-enforcement career, including Field Training Officer, Narcotics Officer, and Water Rescue Training; and

Whereas he has worked on numerous long-term and complicated theft investigations and as a task force officer has assisted by means of his extensive knowledge in the cargo theft field in investigations that have netted millions of dollars in recovered stolen merchandise; and

Whereas he has been assigned as a Port of Los Angeles Police Department Sergeant in a multi-agency cargo theft task force as a supervisor of both LAPPD and outside agency detectives, tasked with prevention and investigation of cargo theft, including search and arrest warrant preparation and execution, liaising with industry representatives, cargo recovery and filing of cases; and

Whereas he is an internationally recognized authority on cargo theft and the preventive interdiction of intellectual crimes; and

Whereas he was a key founding member of the Port Police Dive Team and received a Diving Credential from the College of Oceaneering, as well as numerous Peace Officer Standards Training Certificates; and Whereas he has always been acknowl-

edged as a dedicated and committed employee, highly spoken of by peers, the Port of Los Angeles Customer community, and superiors, demonstrating a professional caliber of supervisory principals, strong management and leadership skills, and a wide knowledge of the Port and its operations; and

Whereas in 2001 he received a Certificate of Appreciation from LA County Sheriff Lee Baca in recognition of exemplary efforts in his part in the successful team effort and capture of a dangerous and desperate escapee; and

Whereas in 1997 Chief of LA County Sheriff Detective Division acknowledged him for efforts in an outstanding criminal investigation, which resulted in the arrest of two suspects, the recovery of several million dollars of stolen property and the identification of a major cargo theft organization operating throughout Los Angeles; and

Whereas in 1986, along with a partner, he entered a burning apartment building to notify residents while awaiting the arrival of fire units, in the process evacuating an elderly blind resident who would not have escaped otherwise; and

Whereas in 1985 while off-duty, he assisted the LAPD in apprehending an Assault with a Deadly Weapon on Peace Officer suspect, in a circumstance where the suspect may not have been captured but for his pursuit, earning him the City's Career Achievement Award; and

Whereas he has served his country honorably as a member of the United States Marine Corps;

Therefore be it resolved that the Los Angeles Board of Harbor Commissioners wishes to extend its sincere appreciation to Kenneth L. Huerta for his 32 years of dedicated service to the City and Port of Los Angeles, and extends to him and his family its heartfelt best wishes for health and happiness in the years to come.

Club sponsors five City teams in annual Baker to Vegas Challenge Cup race.



- Team 183 LAPD ESD/FSD, 19 hours, 11 minutes and 47 seconds.



# **The Great Gatsby** Rated PG-13



# Special Olympics Torch Run

# Airport Police participates in annual Special Olympics Torch Run.

On June 7, Airport Police officers took part in the 2013 Southern California Law Enforcement Torch Run to promote and raise funds for the Special Olympics. It was the 11th year Airport Police Officers carried the "Flame of Hope."

The Law Enforcement Torch Run included more than 2,000 officers from local, county, state, federal and military agencies, along with Special Olympics athletes who carried the flame to the Opening Ceremony of the Special Olympics at California University, Long Beach State June 8.

The torch run began May 28 and covered more than 1,500 miles in more than 200 communities. The southern leg began in San Diego and traveled through Orange, Riverside and San Bernardino counties before entering Los Angeles County.

Runners from the FBI passed the torch to Airport Police at the intersection of Pershing Drive and Imperial Highway on the southwest corner of Los Angeles International Airport (LAX) June 7. Airport Police participants were comprised of Emergency Service Unit officers and other Airport Police officers who were led by Lt. Robert Rios. The group ran approximately 3.5 miles along eastbound Imperial Highway to the intersection of La Cienega Boulevard, where the torch was passed to members of the Hawthorne Police Department.

Airport Police Chief Patrick Gannon, who was present for the hand-off of the torch to Airport Police, wished everyone the best as

Three main legs (North, Central, and South) joined together June 8 in Long Beach for the 2013 Summer Games. There, the three torches were "unified" into a single flame that lit the opening ceremony cauldron.

The Law Enforcement Torch Run was created in 1981 by Chief Richard LaMunyon of the Wichita (Kansas) Police Department as a way to involve his officers in the community by supporting their local Special Olympics organization.

Now, more than 30 years later, the event includes more than 125 separate runs in more than 48 nations. Since the event's inception, more than 90 law enforcement agencies nationwide have raised more than \$414 million to support community-based sports programs for people with intellectual disabilities.



# SUMMER COLESLAW

Coleslaw is a staple side dish to any summer grilling. There are many different ways it can be made, and the flavors can be tweaked to accommodate your taste preferences. In this recipe, the preparation time is probably under 15 minutes before it goes in the refrigerator for cooling. Placing it in the refrigerator also helps the other ingredients – the vinegar, salt and sugar – to penetrate the slaw for enhanced taste.

I have also included diced onion, and a Hawaiian variety at that. This variety tends to be sweeter and less pungent than the typical white onion. Also, I use almond slices to add a certain crunchy texture, which you will find adds character to the recipe.

# **Summer Coleslaw**

## **INGREDIENTS:**

- 2 cups shredded cabbage coleslaw; it can be found at the grocery store in the non-frozen food section as a bag
- 1/4 cup almond slices
- 1/4 cup shredded Brussels sprouts (optional)
- 1/4 cup mayonnaise
- 1/4 cup finely diced sweet white onion; Hawaiian onion is preferred
- 2 tablespoons extra virgin olive oil
- 1 teaspoon sea salt
- 1/4 cup sugar
- 2 tablespoons rice wine vinegar
- Pinch of dried parsley for garnish



You may also use a product called broccoli slaw, which can be used instead of cabbage. Secondly, you may use brown sugar as part of the ingredients.

[ A Cook's Dictionary ]

Coleslaw:

1 In a large bowl, combine the shredded cabbage (or broccoli slaw), almond slices, shredded Brussels sprouts, mayonnaise, diced onion, olive oil, sea salt, sugar and vinegar. Mix all ingredients until they appear well distributed. Mayonnaise may clump, so extra care must be taken to mix it throughout the bowl.





Serves 4

Place the bowl with the ingredients into the refrigerator for cooling and marinating. It is ideal to let sit for about an hour.


From the Dutch koolsa, meaning "cabbage salad" – kool ("cabbage") plus ("salad"). Coleslaw is a salad of shredded red or white cabbage mixed with a mayonnaise, vinaigrette or other type of dressing. Other ingredients including chopped onion, celery, sweet green or red pepper, pickles, bacon or herbs may be added. There are probably as many variations of coleslaw as there are cooks.
