





LAPD: On Jan. 26, four LAPD Officers who saved a downed pilot's life were honored for their heroic act by Congressman (and former Councilman) Tony Cardenas and the Montague Charter Academy Elementary School.

The four Officers - Sgt. Joseph Cavestany and Officers Christopher Aboyte, Robert Sherock and Damien Castro – pulled the unidentified pilot out of the cockpit of his small private plane that experienced mechanical failure and landed on Metrolink railroad tracks in Pacoima. Only moments later, a Metrolink train collided with the downed plane. Their quick actions saved the man's life.

Applying for Retirement Online: Members are encouraged to submit their retirement application 60 days before their retirement date when using LACERS' new Retirement Application Portal (RAP). The RAP is a great asset to LACERS Members that helps to streamline the retirement process. While the filing period is within 30 to 60 days of your retirement date, starting your application early and submitting it on the first day you can at the 60-dayprior mark, will allow for a couple of benefits. These include having ample time to discover any complications and address them without having to move your retirement date, as well as ensuring LACERS staff has time to meet your retirement date request.

For example, if your desired retirement date is March 26, 2022, you would aim to submit your retirement application in the portal on Jan. 25, 2022. For more information, please visit lacers.org/applying-retirement.

Tax Information for City Retirees

LACERS is sharing information related to taxes for City Retirees. That information is below.

LACERS 1099-R Forms

LACERS has completed its mailing of 1099-R tax documents to Retirees and beneficiaries for the 2021 tax year. Please note that 1099-Rs are sent only to the address on file with LACERS. Therefore, if you have recently moved or changed your address, update it with LACERS as soon as possible by submitting a Change of Address form that is accessible at lacers.org/

Reminder: Tax Form 1095-B and Form 1095-C

Tax season is here, and as you prepare to file this year, please be aware that you may receive one or more forms providing information about the healthcare coverage that you had or were offered in the previous year.

Although proof of health insurance is not required for 2021, most retirees will receive a Form 1095-B, which is sent to them directly from either the Centers for Medicare and Medicaid Services (CMS) or their health plan carrier through LACERS (i.e., Kaiser Permanente or Anthem Blue Cross). Some retirees may receive both a Form 1095-B and Form 1095-C if they retired within the last year; one will reflect their LACERS coverage and one will reflect their City of Los Angeles coverage while working.

Please do not contact LACERS if you do not receive your form(s) as LACERS does not generate or have access to them. You may request a duplicate directly from your health insurance

For questions about using Forms 1095-B and 1095-C to file your taxes, please consult with your tax adviser or the Internal Revenue Service (IRS).

The 2022 Joannie Mukai Club Scholarship Program, which ▲ expects to grant 20 awards of \$500 each, is now accepting applications.


Application and Eligibility

Joannie Mukai was a pioneer as the LA Port's Director of Construction and Maintenance. A passionate supporter in the Employees Club and longtime Club Insurance Board Member, she



died in March 2010. The Club's annual scholarship program was named in her honor. "She believed in education and training, and in preparing for success," CEO Robert Larios said. "That's what the Club Scholarship is all about, and we're delighted to name it after her. It's a perfect way to keep her memory alive."

Eligibility requirements:

- All Club Members and their spouses of any age; and children, grandchildren, step-children, foster children and nieces and nephews of Club Members under the age of 25; are eligible to apply. Club Members must be in good standing.
- The successful candidate must attend an accredited four-year college or university full time in the fall semester 2022. Current high school seniors matriculating to a four-year school in Fall 2022 are eligible.
- Candidates will be judged for academic excellence, community service and financial need.
- Scholarships are expected to be awarded in equal amounts of \$500 (each).
- Deadline: Applications must be completed online at the Alive! Website and submitted electronically by 11:59 p.m. June 30, 2022. All applications must be completed in their entirety and submitted at that time to be eligible. Sorry, but the Club is not responsible for delays in delivery

LAPD: A large-scale funeral service was held Feb. 2 for slain LAPD Officer II Fernando Arroyos at Forest Lawn Cemetery in the Hollywood Hills.

Officer Arroyos, 3 years of City service, was shot and killed while off-duty Jan. 10, officials said. He was killed as he took police action when three men attempted to rob him at gunpoint while he and his girlfriend were house hunting in unincorporated Los Angeles County. Officer Arroyos directed his girlfriend to safety as the men opened fire on him. He was taken to a local hospital where he died from his injuries.

Officer Arroyos is survived by his mother, stepfather and girlfriend. He had three years of service with the LAPD, was stationed at Olympic Division, and was a Club Member.

Earlier, on Jan. 16, colleagues at Olympic Division held a fundraiser to pay for funeral expenses. As his death occurred off-duty officially, his family was responsible for funeral and other costs, according to media.

Rest in peace, Officer Arroyos. And thanks to those who rose above the tragedy to help take care of his family.

Two City departments team up to produce the ambitious

LAX Art Program, which has turned the airport into one of the

country's most visited art galleries.

uick: Which is LA's most visited art gallery? The Getty? The Broad? LACMA? Are you sure?

They are all impressive, and we love them. But consider: In 2019, the year before the pandemic, LAX handled more than 88 million passengers. In various

years before that, LA's biggest art museums drew maybe 10 million per year, as best we at the Club can calculate.

But wait, you say. LAX is, well, an airport. (And a great one.) But look around while you're getting your Starbucks and pulling up the boarding pass on your phone – there is fine art everywhere. Last year, 2021, LAX presented 119 different artworks in 18 different exhibits (some permanent, some limited-time).

The impressive LAX Art Program, the product of two City departments working together – LA World Airports and Cultural Affairs – and a local gallery, has turned LAX into a strong presenter of vibrant west coast contemporary art. LAX is often the only view of this vital art scene that visitors will ever experience, and the LAX Art Program takes that responsibility very seriously. (The program also includes performance art and music, which have been limited during the pandemic.)

In these pages we're showcasing the art at LAX that you may have missed, and encouraging you to look again.

(One important note for those wanting to experience the art firsthand: Your visit will have to be travel-related. Entry to LAX is allowed only for airline passengers and persons meeting, accompanying or assisting them, and airport personnel whose employment requires their presence. LAX is closed to the general public 24 hours a day, seven days a week.) ■

LA Rhapsody – Super Moon/Opus No. 1

Karchi Perlmann LOCATION: Level 3, post-security

Upon first encounter, *LA Rhapsody* portrays a majestic view of the city, but closer inspection reveals that the artwork serves as a platform to examine the daily life of the city. It exposes a multichotomous world where the iconic, the privileged, the mundane and the underrepresented coexist within a stone's throw.

Composed of a Corten steel column bisected by a spine of clear acrylic, the 11-foot-tall artwork highlights DeLap's facility with geometric shapes and lifelong interest in magic as the upper portion of the column appears to mysteriously float atop the lower segment.


Your Body Is a Space That Sees



About the LAX Art Program

he mission of the LAX Art Program is to present diverse and memorable art experiences to enhance and humanize the travel experience at LAX and the LAX FlyAway bus terminal in Van Nuys. Featuring local and regional artists through temporary exhibitions, permanent art installations and cultural performances, the Art Program provides access to an array of contemporary artworks that reflect and celebrate the region's creative caliber.

The LAX Art Program began in 1990 and has grown to include rotating art exhibitions, permanent public art installations and music and cultural performances to enhance and humanize the travel experience. Los Angeles World Airports has been partnering with the Dept. of Cultural Affairs for more than 17 years, during which time LAX has presented more than 150 art exhibits featuring hundreds of artists from Los Angeles and the surrounding region.

The program presents up to 20 exhibitions a year in collaboration with Cultural Affairs to create vibrant public spaces at the airport.

Exhibition sites are located at departure and arrival areas that serve both the traveling public and visitors alike. These intersecting sites of engagement provide the first experiences of contemporary Southern California art as travelers enter Los Angeles, and they offer the final artistic impression as travelers return home.

The LAX Art Program proudly features Southern California artists and curators working in the field today, resulting in exhibitions and installations that reflect the identity of Los Angeles—its aspirations, its values, and its imagination.

In 2021, the program displayed 18 exhibitions containing 119 artworks from paintings to sculptures and even a sound art installation that presents a tapestry of compositions reflecting Los Angeles' acoustic offerings.

A committee has been formed to begin to develop, curate and produce art for the airport's massive Landside Access Modernization Program consisting of a people mover and stations, new terminal buildings and bridges, and remote parking structures and a consolidated rental car facility. One percent of the total budget of the Landside Access Modernization Program is reserved for public art.

Library, 36 years of City service

s I enter my 10th year as a member of the Employees Club of Acalifornia, I received the February 2022 issue of *Alive!* the other day. I was saddened to see that the section "In Memoriam" listed a familiar name, L. Gordon Brooks. This must have been Gordon Brooks, I thought sadly, seeing that he served 36 years in the Library.

Gordon worked at the Central Library for some or all of the years I was there from 1976 to 1986. We did not have too many conversations, maybe because I was a young Clerk-Typist, and he was a professional Librarian. We did not work in the same section, but because he roamed the book stacks throughout the Central Library, our paths naturally crossed.

Gordon belonged to a special "elite" group of librarians at Central - he was a SCAN Librarian. The acronym stands for Southern California Answering Network. Formed in the late 1960s, SCAN was headquartered at Los Angeles Public Library and was the last recourse in Southern California for difficult reference questions that needed to be answered. SCAN was supported by federal funds for library services.

Before the convenient days of the World Wide Web and Google, anyone seeking information on anything from businesses to health advice to homework assistance to puzzle solutions heavily depended on the Library for its books, newspaper clippings, indexes, encyclopedias, guides, maps, and so on. Gordon was one of the many subject specialists who made up SCAN.

My memory of Gordon is of him standing by a shelf holding an opened book and being deeply immersed. He was someone I did not know well at all, yet after more than 40 years what resonates is the quiet kindness he bestowed upon me.

Out of curiosity I speedily conducted "arm chair" Internet research. I uncovered that the game of chess was a lifelong avocation for Gordon - he presided over the Santa Monica Bay Chess Club; he voluntarily organized local area championship tournaments; and at the Arcadia Chess Club he competed in 732 games in a span of 20 years. I learned that in 1967 he was on staff at the Central Library, and on the job he equally demonstrated activism - he was on a committee that soon became the Librarians Guild and a chartered union in the AFL-CIO by 1968.

These discoveries about his life allow me to come to the conclusion that Gordon Brooks led a very impactful life.

The Ancient. Friendly Town of Winchester

If you are visiting England for the first time or passing through London's Heathrow Airport to catch a cruise ship from Southampton, the lovely picturesque city of Winchester might be a perfect destination. I suggest you get to Terminal 2 and catch the National Express coach for a one-hour ride along the M3 motorway to central Winchester. After a long flight, the last thing travelers want is to struggle with your luggage on the Underground or hire an overpriced car rental driving through traffic on the "wrong" side of the road. Coach tickets can be bought in advance online, and my advice is to always pay the small extra fee in case your flight is delayed.

Winchester is a city, but it feels more like a bustling market town. Apart from great historical interest, Winchester has been voted as the top place to live in England. This accolade is due in large part to the friendly ambience and low crime rate. It is a city geared up for tourism with a broad range of accommodations - Mercure Winchester Wessex Hotel, centrally nh street area offe coffee shops where we enjoyed tasty cakes and a quick caffeine and sugar

boost (!) while we sat listening to street buskers.

The Old Vine pub stands at the end of the Square near a tree-lined path leading to the cathedral entrance. Many restaurants are offering patrons alfresco dining. We enjoyed something different when we tried the

Stable Pizza, which specializes in unusual pizzas, and a pint (or two) of real Somerset Cider. After our lunch we took some time to wander around Great Minster Street and the Square. We came upon the 24 bollards that are painted in the style of famous artists, like Henri Matisse, Piet Mondrian and Jackson Pollock.

Entering Winchester by coach at the eastern end of the Broadway you're met with a striking statue of King Alfred the Great standing in the center of the road facing toward the center. The coach stops adjacent to the statue; from there it is a two-minute walk to the impressive Gothic Revival-styled Guildhall and Tourist Information Office beside the beautiful Abbey Gardens' well-tended flower borders alongside the river.

When the Romans invaded Britain under Caesar in AD 43, they made Winchester their capital city named Venta Belgarum. Later the invading Saxons called the Roman settlement Venta Caester or Marketplace of the Belgae, which then became.

Review: Las Vegas Golf Club Course

I recently had the pleasure of joining my friend of decades, Steve King (Retired from the LADOT), for a round of golf at the Las Vegas Golf Club course minutes away from the strip. We used to play basketball and softball (on the Intergalactic), but ahem, that was a couple of minutes ago.

The Las Vegas Golf Course is fairly flat; a few of the holes are bordered by streets, but

most are not. I played in the fall, and the weather was perfect - polo shirt, beautiful blue skies, puffy white clouds and snowcovered mountains in the distance. There's a huge driving range, hitting off matts, and the facility is well organized and in good shape. The course is 5,917 yards playing from mid tees. One of the holes I liked best was number 3, a 98-yard par-three over water and backed by four bunkers.

The course was designed in 1938 by famous golf course architect William P. Bell and still provides wide fairways, generous greens and many stunning backdrops. Timing the round to finish at dusk – well you know – you can catch some incredible views.

I'd certainly play this course again, but I also wanted to bring up a course Steve mentioned called Bear's Best in Las Vegas.

The Bear was Jack Nicklaus, one of the best golfers of all time, who also designed golf courses around the world. These courses are the inspiration for the 18 holes of Bear's Best in Las Vegas. The



course is near Summerlin, at 11111 W. Flamingo Rd. in Las Vegas. I couldn't play the course but I did visit it, and it looks amazing. The practice facility is wide, long and full of healthy grass. Many of the holes have views of Vegas, so a round includes incredible vistas. Vegas has quite a few courses, so let me know of any you recommend!

If you don't have time for a round, try the TaylorMade Golf Experience on Las Vegas Boulevard near the airport. It has a double deck driving range if you just want to hit that, but you can set up a time to try out clubs and get fitted. In addition, it has a nice little par-three course. Being near the airport, there's wind and the planes fly overhead, but what a great time to practice shots into the wind!

Keep it on the short grass. ■

LACERS BOARD UPDATE

LACERS Adopts New Benchmark for Private Equity

When I sit down to write this column every month, I do what I can to keep from "getting deep in the weeds," becoming too preoccupied with details or complexities of how our pension plan is run. However, every now and then I see a reason to break one of my rules. Like today, when I want to cover how we evaluate performance in one of our most profitable asset classes, private equity.

Private equity covers a wide range of investments that have the potential for very high returns. However, unlike publicly traded securities, there is no daily pricing of private

equity investments that can be used as a good yardstick (benchmark) for investment performance comparisons.

Why is this so? First, let's look at what we are doing and why. The LACERS Board and investment staff want a good yardstick to measure performance. For instance, if the asset class is big U.S. companies, then we use the Standard and Poors S&P 500 index as that asset class benchmark. Stocks of the largest 500 publicly traded U.S. companies are in that index, and their prices are readily available. This is a straightforward approach used to compare and evaluate the investment performance of LACERS' investment managers that use strategies and skill to actively buy and sell some of those same stocks, with the goal of outperforming that S&P 500 index benchmark after fees.

There is nothing directly comparable for private equity, so we have been using a custom benchmark - the Russell 3000 index plus an additional three percent. The Russell 3000 index is comprised of the largest 3,000 U.S. stocks. We added three percent as an additional investment performance hurdle as a "liquidity premium," to compensate for private equity investments being locked up for years. In other words, we expect private equity's investment performance to outperform the Russell 3000 index by three percent.

Since the timing of valuations between securities in public equity markets and the more difficult-to-price private equity holdings are often out of sync, the result can sometimes be very misleading.

A good example is LACERS' recent private equity one-year return for the period ending Sept. 30, 2021 of 56.79 percent. This exceeded our benchmark by 21.05 percent. While we are pleased by this result, we understand that part of the magnitude of the outperformance was driven by the timing of the valuations.

The opposite market climate can also give inaccurate readings. There have been and will continue to be occasions in which private equity investments lagged valuations or are equal to or underperforming those in public markets. In those situations, the Russell 3000 plus three percent sets a very high bar that makes nearly all private equity investments look less attractive.

Another limitation of using the Russell 3000 index plus three percent as LACERS' private equity benchmark is that this index is made up solely of publicly traded U.S. companies. However, approximately 23 percent of LACERS' private equity portfolio is invested in non-U.S. companies.

The LACERS Board approved a joint recommendation from our general investment consultant, NEPC, and our private equity consultant, Aksia ToreyCove Partners, to begin using the Cambridge Global Private Equity and Venture Capital Index as a private equity benchmark. It is a better representation of LACERS' private equity portfolio and provides a robust, meaningful universe for peer group comparisons.

David Clark; and Ms. Gabriel's long-time friend for over 60 years whom she supervised for several years, Mrs. Letty Herndon and her husband, James.


Carrie's home was adorned with balloons, flowers and birthday decorations. Robert Larios presented her with a

The Structure of The LACERS Board

With Mayor Eric Garcetti likely heading off to India in the near future, it's a good time to review the structure of the LACERS Board of Administration.

The LACERS Board consists of seven members:

- Four are appointed by the mayor (one of whom is required to be a LACERS
- Two are elected by active LACERS members: and
- One is elected by Retired LACERS members.

The Board members are appointed to fixed five-year terms and have staggered end dates at the end of fiscal years.

The four appointed Board members frequently are replaced fairly shortly after a new mayor comes into office. Often, a new mayor will replace board members on higher profile City commissions before getting around to the LACERS Board, but traditionally the time does come for new appointments.

Because the mayor does get to appoint a majority of the LACERS Board, the selection and vetting of the proposed commissioners should be very important to LACERS members. This is especially true for the appointed Board member who is a LACERS retiree, as this position presumably was created to help provide some balance between the appointed and elected Board members.

As the appointed Board members tend to be replaced with each new mayoral administration, it's important to have experienced elected commissioners during these times of transition. It takes time – usually a couple of years – for new Board members to fully understand their roles and the various retirement concepts they need to grasp. While the learning process is taking place, it is the experienced commissioners – usually the elected ones who must be extra vigilant for the protection of our hard-earned retirement benefits.

Well done, Ben!




Writing it "was quite challenging, certainly equal to anything I've ever undertaken while working in the City," he continues. "But it was a labor a love from start to finish.

Changing of the Chief

Chief Terrazas to retire; Fire Marshal Crowley nominated.

LAFD: On Jan. 18, Mayor Eric Garcetti and City Council President Nury Martinez announced that Fire Chief Ralph Terrazas will retire after nearly 40 years of City service, and that Kristin Crowley, a top deputy with 25 years of City service, has been nominated as its next Chief. At press time, she awaits confirmation by the City Council. Her current title is Acting Administrative Operations Chief Deputy and Fire Marshal. If confirmed, she will be the City's 19th Fire Chief and the first woman to ever lead the LAFD.

"Throughout her distinguished career, Kristin Crowley has proven her brilliance, determination and bravery on the job again and again," said Mayor Eric Garcetti in a statement. "She's also shown this City her heart, with her tireless commitment to helping students access life-changing educational opportunities. There is no one better equipped to lead the LAFD at this moment than Kristin. She's ready to make history, and I'm proud to nominate

her as the Department's next

Crowley is a 22-year veteran of the LAFD who has moved seamlessly through the ranks, proving her credibility and character along the way. She made history as the Department's first female Fire Marshal and is the second woman to earn the rank of Chief Deputy.

Chief Deputy Crowley, who serves as program director for the LAFD's youth development program, has played a key role in ensuring that more than 1,000 LAUSD high school students continue in their education.

In her current role, she helped to develop a five-year strategic plan to identify areas of growth within the Department and foster culture more open to change. As Chief, she plans to work to both deepen existing efforts and create new mechanisms to foster equity and inclusion in the Department.

"I am honored and humbled by the opportunity to be the next Fire Chief of the Los Angeles City Fire Dept. and to lead the Department into the future," Crowley said in a statement. "As the Fire Chief, if confirmed, I vow to take a strategic and balanced approach to ensure we meet the needs of the community we serve. We will focus our efforts on increasing our operational effectiveness, enhanc-


> ing firefighter safety and wellbeing, and fully commit to fostering a diverse, equitable, and inclusive culture within the LAFD. Thank you, Mayor Garcetti, Council President Martinez, and Chief Terrazas for entrusting me to lead and to work with the dedicated women and

men of the finest department in the world."

Chief Terrazas, who was sworn in as L.A.'s Fire Chief in 2014, was the first Latino to serve in that role. A 39-year veteran of the Department, Chief Terrazas helped steer the City through some of its greatest challenges, and brought about meaningful advancements and innovations within the Fire Department.

Early in his time leading LAFD, Chief Terrazas oversaw the rebuilding of the Department, which had stopped hiring new firefighters for five years as a result of the Great Recession. In 2015, he successfully reorganized the Department into four bureaus - the first restructuring of LAFD in 50 years, which helped to enhance accountability and improve service deliv-

Chief Terrazas also launched and implemented a variety of innovative initiatives. including Advanced Provider Response Units, Alternate Destination Response Units, and Fast Response Vehicles, efforts that enable firefighters to go beyond simply bringing patients to emergency rooms. Chief Terrazas has also made diversity a top priority – for the first time in department history, 51.4 percent of firefighters are now people of color. Since 2014, the Department has maintained a steady

increase in the number of hired sworn women at LAFD. Of the current sworn force, more than half of those who are currently employed were hired on in the last eight years, and nearly 10 percent were brought on in 2021.

Under his leadership, the LAFD supervised the City's free public

COVID-19 testing and vaccination programs, which has administered nearly 4.86 million tests and approximately 1.43 million vaccinations to date. The City of L.A.'s testing effort was the nation's largest municipal testing program and tested more than 40,000 Angelenos per day at

"For nearly eight years, we made considerable strides in technology, implemented innovative ways to respond to emergencies, and became a model for other agencies. 



Letter From England, Pt. 4 **Continued from page 15**

Wintancaester, followed by today's name for the city, Winchester

Four hundred years later in AD 407, with the Roman Empire crumbling, the last Roman legions were withdrawn from Britain and the country fell into a dark age. Hosts of invaders and settlers followed, including Germanic migrants, the Jutes from the Jutland peninsula (modern-day Denmark), the Angles from Angeln in southwest Jutland and the Saxons from northwest Germany. These tribes formed their own small kingdoms; most of these kingdoms survive to this day and are better known as the English counties Kent (Jutes), East Anglia (east Angles), Sussex (south Saxons), Middlesex (middle Saxons) and Wessex (west Saxons).

King Cenwalh of Wessex built the first church in Winchester, which became a cathedral in 660. St. Swithun is buried outside the cathedral upon his request, and legend has it that when an attempt to move his body was made, it began to rain and continued to rain for 40 days and nights, giving rise to

St Swithn's day, if thou be fair, St Swithn's Day, if thou bring rain. For forty

St. Swithn's remains were eventually moved 100 years later, with no reports of rain! However local people still believe that if it rains on St Swithin's day, then it will continue to do so for 40 days.

Winchester was attacked and plundered regularly by the Vikings until the 9th century, when King Alfred removed the old Roman street plan and designed a new one. The new plan was easier to defend and would protect the city's prosperous wool trade.

During the Norman Conquest (1066), William the Conqueror ordered the old cathedral be pulled down to make room for a new one farther south. Many of the old Saxon kings' tombs were moved into the new cathedral. Over the centuries, the cathedral has grown into one of the largest Gothic cathedrals in Europe (the impressive Duomo di Milano in Italy is the largest), but it does have the longest nave (the central part of the cathedral) or the longest overall

Among the cathedral's most famous occupants are Jane Austen; Edmund Ironside; Cnut the Great, King of England, Denmark and Norway; and King

Next to the cathedral sits the oldest continuously running school in Britain, originally built to educate poor scholars in 1382, and where today you will find The Pilgrims' School, a private boarding school. Many successful and famous people have studied there, including Britain's current Chancellor of the Exchequer, Rishi Sunak, whom some believe will be the next Prime Minister. The school has one of the earliest hammer-beamed buildings known as Pilgrim's Hall, which is still used by the school's Senior Commoners for choir rehearsals. Near to the school and a short walk from the cathedral is the historic and cozy Wickham Arms pub, where you can have a drink whilst sitting on the old wooden Pilgrims School desks whilst looking at the amazing number of historical objects dotted all over the walls

In nearby Great Hall of Winchester Castle hangs a replica of the legendary King Arthur's round table, built in the 13th century and later painted on the order of King Henry VIII while taking a rest between wives. King Henry had the names of Arthur's knights added to the table along with a Tudor rose in the middle as a nifty piece of propaganda.

Other places of interest to visit are the City Museum on the corner of Great and intricate figures; and the city's Water Mill, to the north of the city. The mill has been newly restored and is driven by the River Itchen that runs through the city and it is still milling corn by waterpower today.

Twice a month on Saturday there is a large farmer's market, with more than 100 stalls mostly specializing in local food, plants, and wares. In July, Winchester hosts the annual Hat Fair, the UK's longest running festival for street artists and entertainers. The final day of the fair wraps up with a huge picnic at the city's North Walls recreation ground.

Walking around the city's narrow cobblestone side streets with their dark gothic architecture, or standing outside some of England's oldest pubs at night, it isn't difficult to imagine the way people lived between fear, famine, war and the Black Death all those years ago.

Back to the present and on a lighter note, Academy Award winning actor Colin Firth is from Winchester and was educated at Montgomery of Alamein School (now Kings' School). The Bangkok Bistro, a restaurant he regularly visits, offers The Colin Firth Curry on its menu.

For more local news, myths, and legends, take a seat at the bar in Alfie's pub opposite the Guildhall. Between pulling pints for thirsty customers, the bartender entertained us with the humorous story of King Alfred's sword on the statue outside the pub. According to legend, if a female virgin of at least 16 years walks around the statue three times in a clockwise direction, King Alfred will lower his upraised sword. Well considering that the large statue stands in the middle of a traffic roundabout, this alone makes it a difficult and dangerous act to perform. There may have been a little tongue in cheek to this story as the bartender was Irish!

Tip: There is a direct National express coach and train service to Southampton, with easy access to one of the four cruise ship terminals in Southampton, or direct to Victoria Bus and London's Waterloo train station.

Stop procrastinating; travel while you still can.

Cheers! from next door, and to gossip and see all the latest fashion. Novelist Mary Shelley spent many hours there writing her classic, Frankenstein. Ironically, under a plaque in her honor, outside the restaurant, in a vault, sits an underground electrical substation that delivers thousands of volts of power to central Bath! Jane Austen is another renowned author who also found the Grand Pump Room a perfect observation spot, collecting ideas... two of her novels. The author enjoying taking her afternoon tea in the Pump Room restaurant or attending swamis under the crystal chandeliers in the stunning grand ballroom of the octagon Assembly room building. Look for the plaques posted along the sweeping Royal Crescent and Queens Square, where you will find the names all the famous people who lived there through

Between the Roman Baths and Pulteney Bridge, standing on the ancient cross roads of river and land is the stone Guildhall Market, dating back to 1359. In the center of the market is an interesting small stone pillar (Nail) said to be where the saying "cash on the nail" originated. The story is that the cash transactions between merchants and tradesmen were binding if taking place over the top of the stone pillar (Nail).

Pulteney Bridge is one of only three bridges in the world where buildings continue to operate for merchants and shoppers, with the oldest being Florence's Ponte Vecchio on the river Arno, built in 1345. After Ponte Vecchio is the Kramerbrucke Bridge in the German city of Erfurt over the Gera River and built in 1510. Number three is Bath's graceful Pulteney Bridge over the River Avon, constructed in the 1770s by Scottish architect Robert Adam.

Pulteney Bridge is a wonderful example of Georgian architecture and was a pleasure to stroll along from our Air B&B in the early evening to check out the city's nightlife. There is a small set of steps going down to the river bank on the southwest corner, accessing a towpath and side entrance to the rugby grounds. A peaceful respite can be found in the garden of the Boater Pub by the river. We enjoyed a pint while listening to the weir and admiring the magnificent stone features of the Pulteney Bridge.

Bath has now become the culinary center for southwestern England, and we found a wide variety of places to eat, including the oldest bake house (circa 1483), home of the famous Sally Lunn Bun (a semi-sweet bread). We also discovered a tearoom offering the world's best Cornish pastries, and a really nice Spanish Casa de Tapas with outstanding Rioja red wine. Along the way we enjoyed Joya, an award-winning five-star Italian restaurant, where they serve a great antipasto piccolo, house linguine and a fine bottle of Nero d'Avola. Our favorite was the Green Park Brasserie, offering great cocktails and nightly live jazz in a former 1870s Victorian railway station booking hall.

Our visit to Bath concluded on a crisp Saturday afternoon visiting the local rugby ground, where we watched two local teams battle it out before a full outdoor stadium. Unlike other ball sports requiring dozens of players constantly taking a rest, rugby is played between two teams of 15 players - 45 minutes each way - with an oval-shaped ball and played on a rectangular field called a pitch. The field has H-shaped goalposts at each end; there are no motorcycle helmets, no excessive body armor worn, with only male private parts protected and a couple of extra players in reserve in case of any broken limbs. Post-game, the home team hosts the visiting team to drinks and revelry at the club house. If you ask any Brit who has played the game, this is the best part of the match - no animosity, just camaraderie and respect for a game well played. Rugby is a game played by gentlemen, while football (soccer) is a game played by hooligans.
